



## PUBLIC INFORMATION NOTICE #3 FOR THE CONSTRUCTION OF THE 930 ZONE RECYCLED WATER PIPELINE EN13023

DATE: May 14, 2013

Dear Resident/Business Owner:

The Inland Empire Utilities Agency's (IEUA) contractor will be conducting exploratory digging at various locations along the pipeline alignment to better locate and identify existing utilities.

**LOCATIONS:** The alignment begins at Monte Vista Avenue and Chino Hills Pkwy in Chino travel along the flood control channel, under Ramona Avenue, continuing along the channel under Highway 71 where it will exit the channel at Eucalyptus and Pipeline. Traveling west on Eucalyptus Avenue, down Bluebell Drive onto Daisy Drive where it will go along the flood control channel, and exit at Peyton Drive and Eucalyptus Avenue. The pipeline will connect to an existing recycled water pipeline under Peyton Drive.

DATES: May 15, 2013 thru May 31, 2013

- HOURS: 7:00 a.m. 5:00 p.m. Monday Friday Along Flood Control Channel
- HOURS: 8:30 a.m. 1:30 p.m. Monday Friday On Eucalyptus Ave

HOURS: 8:00 a.m. – 5:00 p.m. Monday – Friday On Bluebell Drive and Daisy Drive

POSSIBLE IMPACTS: Traffic delays may occur. There will be NO utility service interruptions.

**RESIDENT AND BUSINESS' ACTIONS:** Safety is our main concern and we ask for your assistance during this project by keeping children and pets away from work areas and observing all "No Parking" signs.

Benefiting the residents and businesses of Chino Hills and Chino, this project will provide recycled water as an additional source of water for landscape irrigation use and groundwater recharge. This project will save approximately 90 million-gallons per year of drinking water, while helping to drought proof IEUA's service area, help to keep the cost of water low, and provide a reliable source of alternative water. Funding for this project has been provided in full or in part through an agreement with the State Water Resources Control Board and the Environmental Protection Agency.
