



**PUBLIC INFORMATION NOTICE
FOR THE CONSTRUCTION OF THE
930 ZONE RECYCLED WATER RESERVOIR AND
930 ZONE RECYCLED WATER PIPELINE**

Dear Resident/Business Owner:

The Inland Empire Utilities Agency (IEUA) in cooperation with the Cities of Chino Hills and Chino will soon begin construction of a recycled water reservoir and recycled water pipeline. The project includes a **new 5.0 million-gallon reservoir** nestled in the hills between Galloping Hills Road and the equestrian/pedestrian trail to the North. When planning the reservoir, visual impacts were considered thereby designing the reservoir with a low profile, built into the hillside resulting in approximately 4 feet of the structure appearing above ground. As a result, the project includes significant excavation at the project site resulting in truck traffic to remove the excavated materials.

The **recycled water pipeline** will span from Monte Vista Avenue and Chino Hills Pkwy in Chino, where it will go along the flood control channel, under Ramona Avenue, continuing along the channel under Highway 71 where it will exit the channel at Eucalyptus and Pipeline then proceed into Chino Hills. Traveling up Eucalyptus Avenue, down Blue Bell Drive where it will go along the flood control channel, and exit at Peyton Drive and Eucalyptus. The pipeline will cross under Peyton Drive, and will travel along the drainage ditch located between Galloping Hills Road and the Chino Hills Community Park and along the equestrian/pedestrian trail to connect to the reservoir.

Benefiting the residents and businesses of Chino Hills and Chino, these projects will provide recycled water as an additional source of water for landscape irrigation use and groundwater recharge, saving approximately 90 million-gallons per year of drinking water, while helping to drought proof IEUA's services area, help to keep the cost of water low, and provide a reliable source of alternative water. *Funding for this project has been provided in full or in part through an agreement with the State Water Resources Control Board and the United States Bureau of Reclamation. Construction is expected to begin on the reservoir in early 2013. The pipeline portion of the project should begin in late Spring 2013. More specific dates will be forthcoming.

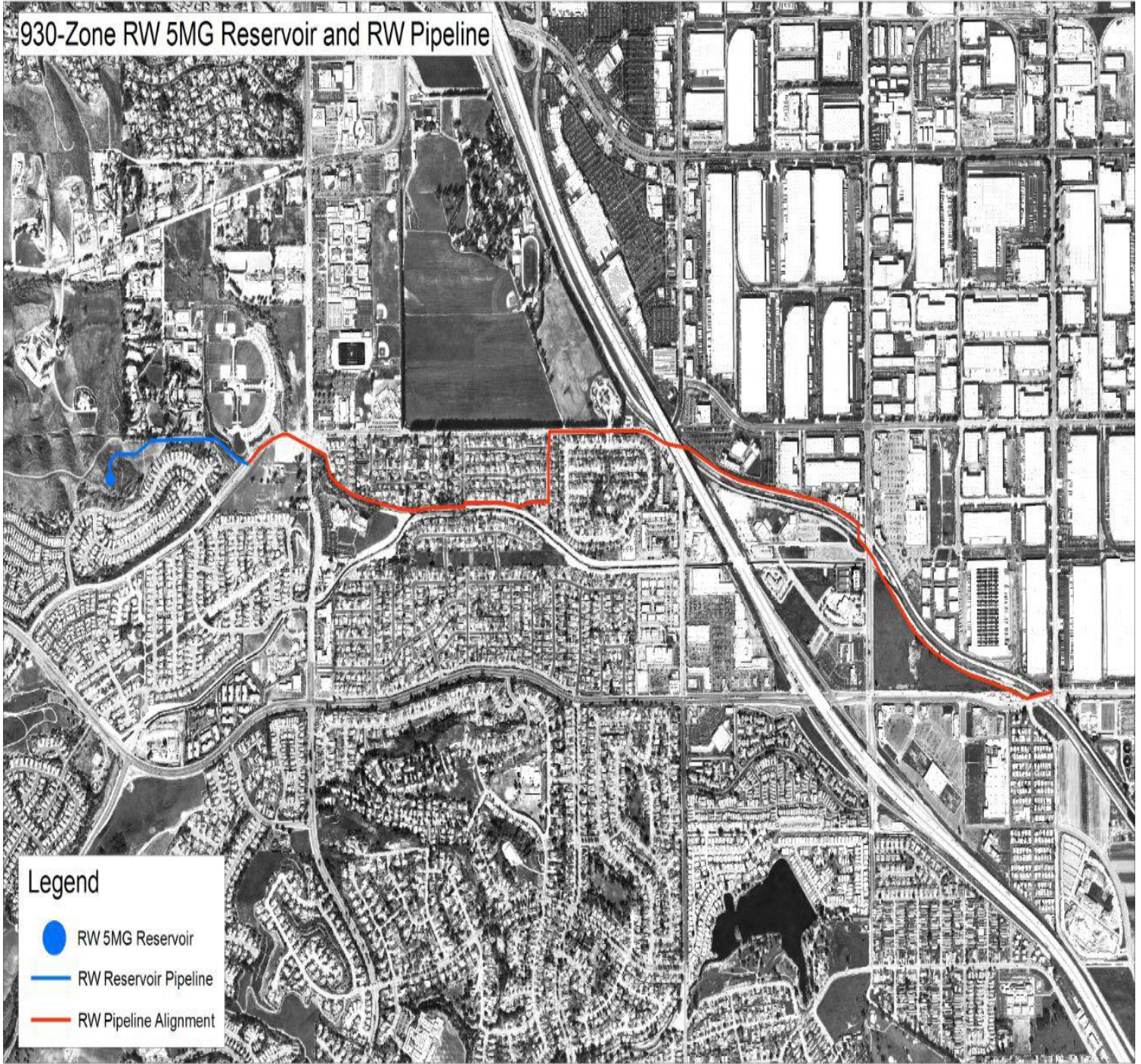
