- 1. Approve a one-year contract for the Landscape Transformation Program to The Brickman Group Ltd. LLC for a not-to-exceed amount of \$400,000; and
- 2. Authorize the General Manager to execute the contract.

D. <u>REGIONAL RESIDENTIAL LANDSCAPE RETROFIT PROGRAM</u>

It is recommended that the Committee/Board:

- Approve a one-year contract for the Regional Residential Landscape Retrofit Program to Conserv Construction, Inc., for a not-to-exceed amount of \$400,000, with two optional one-year extensions for a not-to-exceed contract amount of \$1,000,000, and
- 2. Authorize the General Manager to execute the contract.

- Amend the professional services contract with Carollo Engineers for the Water and Recycled Water Rate and Fee Study, for a not-toexceed amount of \$164,963; and
