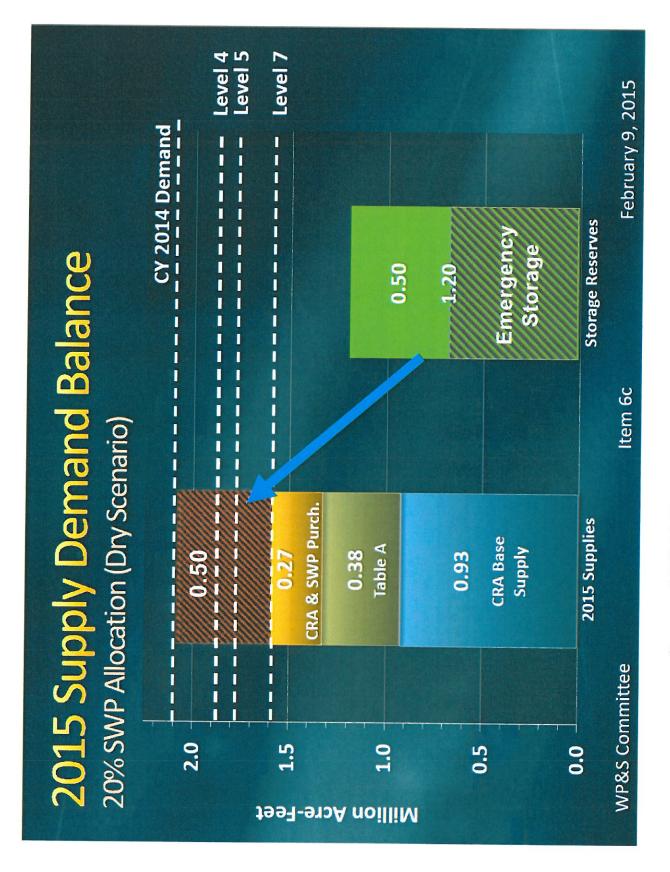

Treasurer's Report of Financial Affairs

RECOMMENDATION

The Treasurer's Report of Financial Affairs for the month ended December 31, 2014, is an informational item for the Board's review. The monthly report denotes investment transactions that have been executed in accordance with the criteria stated in the Agency's Investment Policy (Resolution No. 2014-6-11).

BACKGROUND

The Treasurer's Report of Financial Affairs for the month ended December 31, 2014, is submitted in a format consistent with State requirements.

Total cash, investments, and restricted deposits of \$129,879,217, reflects an increase of \$8,124,179 compared to the total reported for November 2014. The increase of \$8 million was attributed to property tax receipts. The average days of cash on hand for the month ended December 31, 2014 increased to 167 days compared to 155 days reported in November. The increase was due to property tax receipts increasing the non-debt related cash on hand. Average days of cash on hand is calculated using the monthly ending balance of unrestricted cash and cash equivalents divided by disbursements associated with operating expenses, debt service and capital expenditures as recorded in the Agency's cash flow.

The Agency's investment portfolio average rate of return in December 2014 was 0.513%, no change compared to the average yield as reported in November 2014.

The Financial Affairs report is consistent with the Agency's Business Goal of Fiscal Responsibility in providing financial reporting that accounts for cash and investment activities to fund operating requirements and to optimize investment earnings.

IMPACT ON BUDGET

The interest earned on the Agency's investment portfolio increases the Agency's reserves.

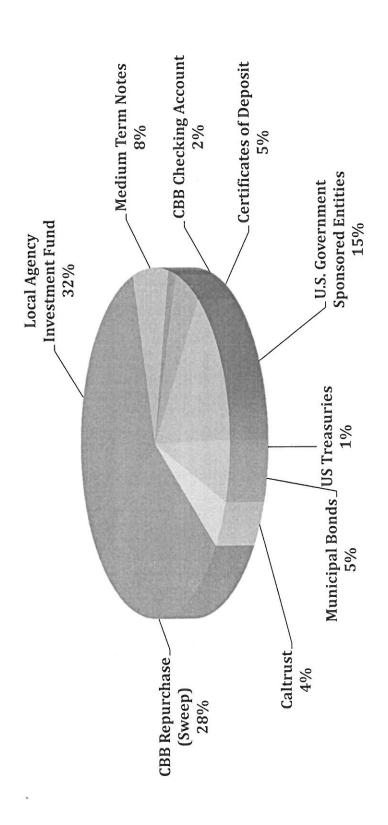

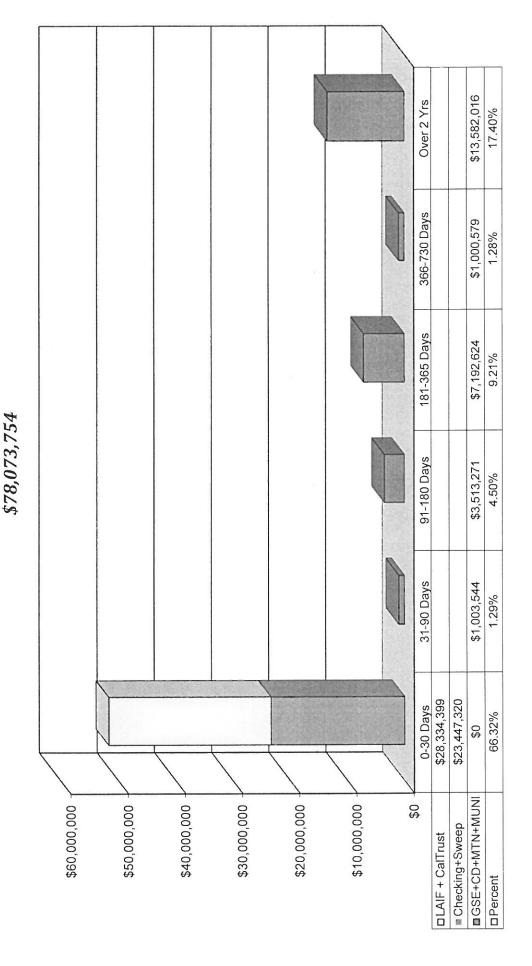

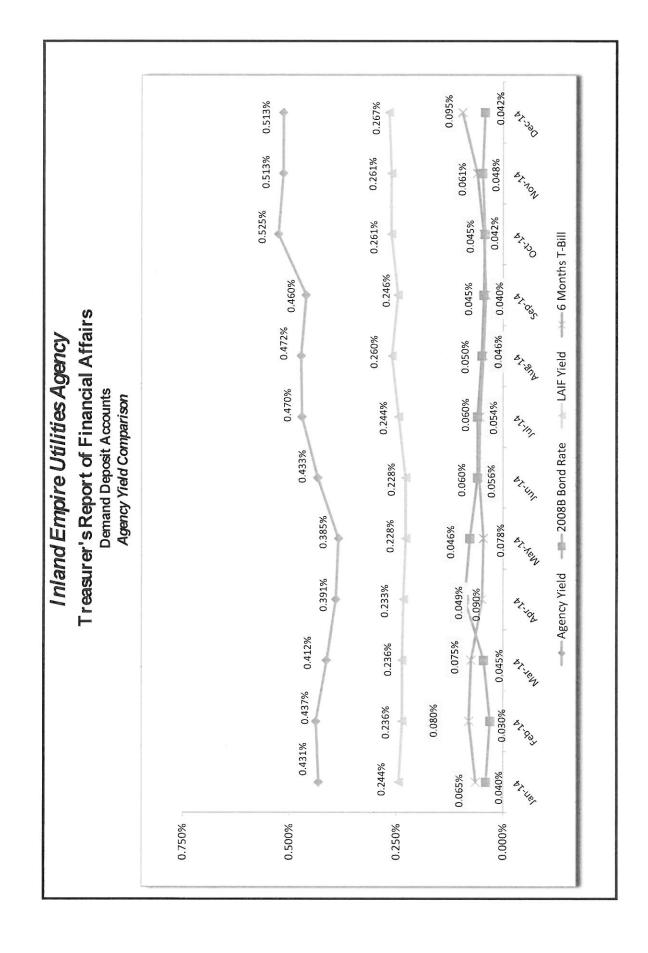


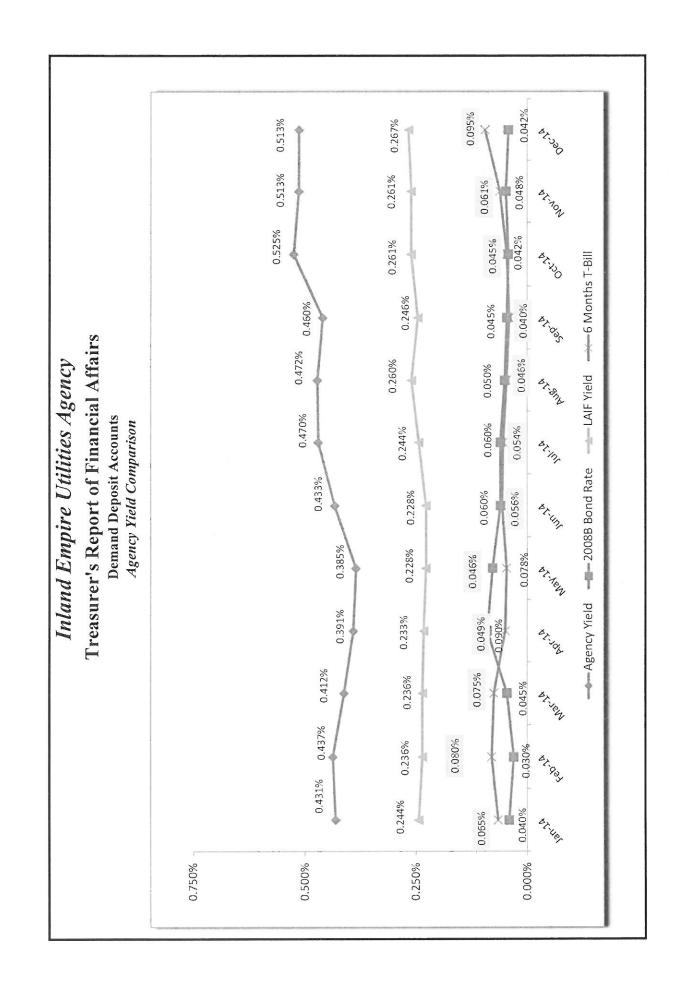

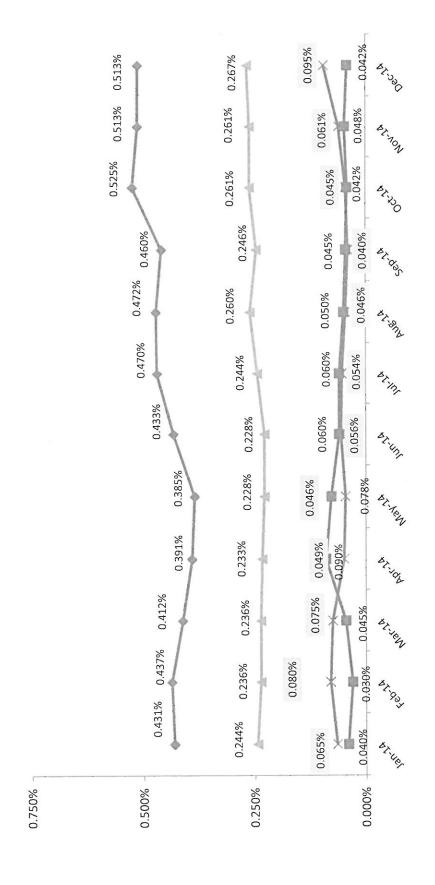

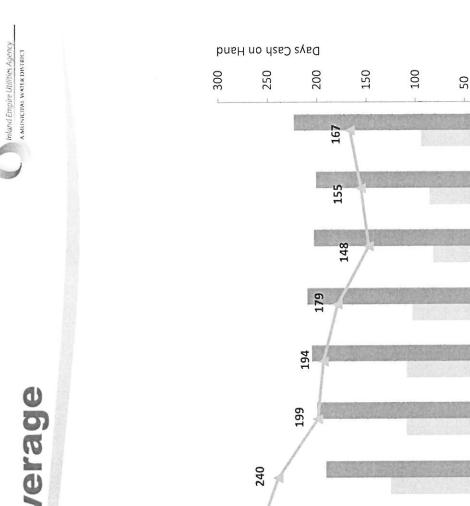
Month End Portfolio Yield Comparison

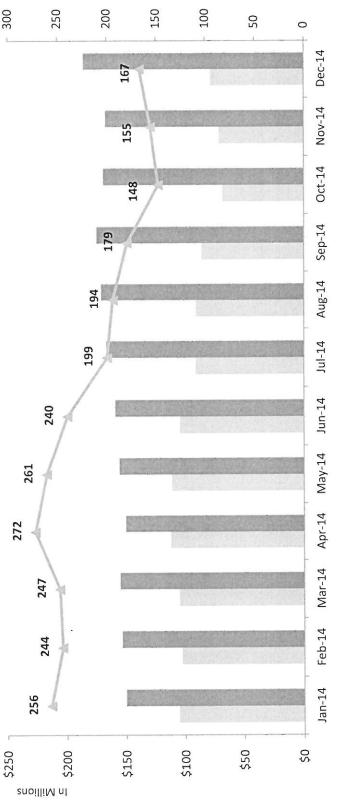

January Monthly Legislative Update

Welcome to the 114th Congress! The House and Senate officially convened in Washington on January 6th. Both the House and Senate are under Republican control for the first time since 2006, during the second term of President Bush. House Republicans quickly set votes to make changes to the Affordable Care Act and encourage the production of additional energy in the United States. The Senate has devoted much of the month to the consideration of the Keystone XL Pipeline. The new Majority Leader Mitch McConnell (R-KY) has promised to have a more open amendment process, which has considerably drawn out consideration of the legislation on the Senate floor. This effort for bipartisan consideration of amendments could have a positive effect on the deliberation of Appropriations bills later this year. The House also got to work on a funding bill for the Department of Homeland Security to fund the agency through the end of the fiscal year. The House bill is not expected to pass the Senate and would certainly face a veto if it made it to the President's desk. The President has promised he will use his veto pen during his last two years in office. The 2016 Presidential cycle has already kicked off with several Republicans announcing they are considering running for office, which will have an impact on Senate votes, as several Senate Republicans will be traveling for campaign events.

Homeland Security Funding Early on the Agenda

The Consolidated and Furthering Continuing Appropriations Act, 2015 appropriations package passed during December funded all agencies except the Department of Homeland Security through the end of the fiscal year (September 30, 2015). The DHS was funded under a continuing resolution that expires on February 27th. House Leaders wasted no time delivering on a promise to act on a measure to block the President's actions on immigration when they allowed amendments to the funding measure that came to the floor earlier this month. Conservatives voted to attach policy riders to undo the President's Executive Memorandum which expanded deferred action on undocumented immigrants.

The fight now moves to the Senate, where Democrats have already indicated they plan to block Republican efforts to bring the bill up for consideration unless the provisions are stripped out of the bill. Many conservative Republicans are still encouraging Majority Leader Mitch McConnell to bring up the measure, saying it deserves a vote on the floor. The latest showdown on the bill is expected to come up next week when the Senate has tentatively scheduled consideration of the bill.

Blame Game over California Drought Bill

Senator Boxer and House Majority Leader Kevin McCarthy (R-CA) have publically traded blame over who is responsible for the failed effort to pass drought legislation at the end of last year. As we reported last month, the House passed a stand-alone California drought bill, which did not pass the Senate. Representative McCarthy told the Associated Press earlier this month that negotiations were heading in the right direction before objections from Senator Feinstein derailed consideration. For her part, Senator Boxer blamed the failure on House Republicans because negotiations left out parties that would be affected by the legislation.

With a new Congress comes another opportunity to pass drought legislation. Representative Grace Napolitano (D-CA) has already reintroduced her Water in the 21st Century bill—a bill she believes could garner support from other lawmakers this year. The Congresswoman believes that the effect of inconsistent water supplies on the nation's economy could foster support with Republicans. Her bill would create both a secured loan program and grants for water recycling, groundwater management, integrated regional water management, and water infrastructure projects. It would also improve water supply operations at dams managed by the Army Corps of Engineers, and improve drought resilience between the Environmental Protection Agency, U.S. Department of Agriculture, and Department of Interior. Representative McCarthy has said he remains committed to passing legislation that would be beneficial to the State as it continues to fight the historic drought, though he hasn't endorsed a specific plan in the 114th congress. Even with majorities in the House and Senate, Republicans might have trouble mustering up the votes if Senator Boxer opposes the final bill. In our conversations with the relevant water committees' staffs, we have learned that they believe a bill that focuses on the region or nation as a whole might be the bill that reaches the floor in the end, as other states, including Texas, have been suffering from drought conditions.

Sequestration in the Spotlight

The President gave his State of the Union Address on January 20th. While the address hinted at some specific program funding levels, we've started to see more information revealed leading up to the formal release of the President's budget on February 2nd. We already know that the President is going to propose doing away with the automatic budget cuts known as sequestration that were included in the Budget Control Act passed in 2011, which set spending caps for a 10-year period and triggered automatic cuts if spending levels exceeded those caps. The President is expected to propose an equal increase in both defense and non-defense spending, arguing that continued budget caps are hurting the economy and military readiness. In total, the President's budget to Congress will exceed the budget caps by \$74 billion. To pay for those increases, the plan will call for spending cuts elsewhere bundled with changes to the tax code that would close loopholes.

Lawmakers on both sides of the isle have come out in support of scrapping sequestration, but that doesn't mean it is going away anytime soon. Many Republicans favor removing those caps on the defense spending side, but aren't as keen as Democrats are on removing the caps for non-defense spending. The House and Senate Budget chairmen — Representative Tom Price (R-GA) and Senator Michael Enzi (R-WY)., respectively, who will write their chamber's budget resolutions in March — have already indicated that their upcoming proposals are likely to focus on more spending cuts, not looking for additional revenue for additional spending. While a

compromise doesn't look likely at this point, both sides could come together for a mix of entitlement reform, tax overhaul proposals, and spending adjustments as deadlines draw closer. We will know more as lawmakers begin to react to the President's proposal after it is released next week.

Outlook for February

The most pressing issue in February will be the passage of legislation to fund the Department of Homeland Security past February 27th. At this point, lawmakers would like to avoid the need for a Continuing Resolution, but a path forward that will appease enough Members on both sides of the isle has yet to emerge. As stated earlier the President's budget will be released on February 2nd, which will outline the President's agenda for the year and start the appropriations process on Capitol Hill. Lawmakers only have one district work week scheduled in February, giving them several weeks to clear legislation in DC. The House has announced its schedule for the month, which includes the following:

- Legislation for a full repeal of the Affordable Care Act, with instructions to Congressional Committees to develop alternative proposals to the law.
- A bill aimed at disclosing the cost of mandates on businesses.
- Charitable tax code provisions
- An overhaul of the Elementary and Secondary Education Act (No Child Left Behind)

Strategic Public Affairs

Overview:

The Legislature returned to Sacramento in early January to organize, work on potential legislation, introduce bills and get settled in for the session. The first day back, Governor Brown gave his combined Inaugural and State of the State address that outlined his vision for the year. While water was not a huge focus of his address, he did mention passage of Proposition 1 and the California Water Action Plan. Most notably, the Governor outlined three new climate-related goals for the state which include increasing the supply of renewable power in the state to 50 percent by 2030, reducing petroleum by 50 percent by 2030 and doubling the efficiency of existing buildings. Since the Governor's address, there has been a lot of talk in the Capitol about how the details of these measures will take shape in the coming year.

Senate President pro Tem Kevin de Leon released the Senate committee assignments for the session. While several members of the IEUA Senate delegation are on the Energy, Utilities and Communications Committee, none were assigned to the Natural Resources and Water Committee.

Governor Brown also released his first draft of the 2015-16 State Budget. The \$164 billion budget includes \$532.5 million in spending from Proposition 1, approximately \$137 million of that for water recycling and desalination. It also includes \$20 million from the Cap and Trade auction revenue funds for waste diversion projects. The Legislature will work in sub committees on the specifics of the budget and finalize a final spending plan in mid to late June.

The Department of Water Resources (DWR) held the initial meeting for negotiations with State Water Project (SWP) contractors on proposed amendments that would modify SWP water supply contracts. Both DWR and the SWP Contractors have specific objectives they are trying to achieve during the negotiations.

The repercussions of the San Onofre Nuclear Generation Station (SONGS) closure continue with a new report outlining the difficulties the closure has had on the transmission of renewable power generated in the Imperial Irrigation District to the areas that are affected by the closure. There have been several transmission plans proposed, but most of those are met with serious obstacles to getting the projects permitted. Transmission, or lack thereof, affects the entire Southern California region that is trying to replace the significant power losses.

Legislators are making another attempt to streamline the California Environmental Quality Act (CEQA). This attempt, SB 122, focuses on "document dumping" right before a project is being taken for a vote by a local agency. Local government experts are concerned that the measure will only create other opportunities for opponents to delay projects rather than make the process quicker and easier. More work will need to be done on this proposal as the bill gets ready for policy committee hearings.

Inland Empire Utilities Agency Status Report – January 2015

State of the State/Inauguration

On January 5, Governor Jerry Brown was sworn in as Governor for his historic fourth and last term. The Governor delivered his combined State of the State and Inaugural addresses and packed significant announcements into his remarks.

Most notably, the Governor announced that he is calling for the state to increase the supply of renewable power to 50 percent by 2030, reduce petroleum use in cars and trucks by 50 percent by 2030 and double the efficiency of existing buildings while making heating fuels cleaner.

The first 50 percent renewable goal was expected my most, as there has been talk about increasing the Renewable Portfolio Standard (RPS) currently at 33 percent for some time. It has yet to be determined if the Governor intends to just increase the RPS, or if a new renewable energy or clean energy program will be created. The 50 reduction in petroleum standard was a surprise to most and leaves many speculating about how the Governor plans to reach this landmark goal in the next 15 years.

There was very little about water in the Governor's address. He briefly noted the passage of the water bond, and how important implementation will be in the coming year. He also mentioned the California Water Action Plan, but there was no mention of the Bay Delta Conservation Plan.

Governor Releases Fiscal Year 2015-2016 Budget

Governor Jerry Brown released his proposed Fiscal Year 2015-16 budget on January 9. The \$164.7 billion budget as expected, includes the first batch of Proposition 1 funding allocations totaling \$532.5 million:

This is only the initial proposal for water bond funding for FY 2015-16. The Legislature will get the opportunity to work on the budget in the coming months and tinker with the funding amounts. Notably, there is no funding for groundwater cleanup in the Los Angeles Basin, a key policy piece in the negotiations before the bond was passed by the Legislature last year.

The proposed budget also includes about \$1 billion in Cap and Trade auction revenue. The general framework for how the funds are to be allocated was adopted in the 2014-15 budget and includes \$20 million to Cal Recycle for waste diversion. Several wastewater agencies were able

to access these funds for projects from last year's budget. Transportation fuels are included in Cap and Trade for the first time in 2015. The Cap and Trade allowance revenue allocations in the 2015-16 budget are only an estimate of the revenue expected from the auctions in the coming year. After the first auction in February, revenue expectations will become clearer and there could be a significant revision to the Cap and Trade allocation portion of the budget in the May Revise. The Legislative Analyst's Office has estimated as much as \$1.3 billion more from Cap and Trade allowance proceeds.

State Water Project Contract Negotiations

The Department of Water Resources (DWR) held the initial meeting for negotiations with State Water Project (SWP) Contractors on proposed amendments that would modify SWP water supply contracts.

The proposed amendments would define the rights and obligations of DWR and the SWP contractors who would benefit from the Bay Delta Conservation Plan (BDCP) ,should the BDCP be implemented.

During the meeting, SWP contractors and the DWR announced their proposed objectives for the negotiations as follows:

State Water Contractors Objectives

Objective 1: Provide enhanced management tools to facilitate greater flexibility for SWP contractors to meet current and future water supply challenges.

Objective 2: Allocate SWP costs of the Bay Delta Conservation Plan proportionate to the benefits received by individual SWP contractors.

Department of Water Resources' Objective

Objective 1: The California Department of Water Resources wants to ensure that the terms and conditions for the proposed Contract Amendments shall allow the continued financially sound operation of the State Water Project in compliance with all legal requirements and provide a fair and equitable approach to funding State Water Project Contractor costs for the proposed Bay Delta Conservation Plan, if approved.

The Contractors are scheduled to make a draft proposal available to DWR by February 4th. The next meeting to further discuss the details of the negotiation is currently scheduled for February 17th.

SONGS Transmission Options Studied

A report outlining more struggles grid operators face as a result of the early retirement of the San Onofre Nuclear Generation Station (SONGS) in June of 2013 and the retirement of once through cooling technology was recently released. According to Cal-ISO, the current transmission system is currently unable to deliver renewable generation from the Imperial Valley to the bulk of the transmission system following the SONGS closure. Additionally, the closure impacts the ability of the system to maintain deliverability of import capability from the Imperial Irrigation District at the required level.

In response to this determination, there have been several transmission system proposal alternatives suggested for analysis at the California Energy Commission. Most of the alternatives come with siting and environmental constraints. For example, one proposal would require a new right-of-way though the Irvine Ranch Open Space, a national landmark. San Diego Gas and Electric's proposed "Imperial Valley to Inland Route" would need to cross sensitive lands in the Anza-Borrego Desert State Park, as well as tribal lands of at least three Native American groups. Other proposals face similar challenges which put most of the projects in the "challenging" to "very challenging" category.

As the conversations continue on how to replace the power and voltage from SONGS, these types of unforeseen consequences only exacerbate the problem created with the SONGS shutdown.

CEQA Reform Bill Causes Worry

Early concerns have been raised over the first draft of a CEQA reform bill introduced in the Senate by Senator Hannah-Beth Jackson (D- Santa Barbara) and others, including Senator Richard Roth (R- Riverside). The intent of the bill, SB 122, is to streamline the CEQA process, but some sections of the bill might make the process longer and more burdensome. Lawmakers are trying to curb "document dumping" where opponents of a project try to delay the process by submitting last-minute comments and other documents on the EIRs to agencies in charge of approving the projects during hearings at which the agencies were scheduled to take a vote on the projects. This delays the vote, as the agencies are required to respond in writing. The legislative proposal would include a separate 30-day comment period for final EIRs with the intent of reducing the number of issues opponents could comment on during public comment periods. Local government representatives are unclear how this would be anything other than just another 30 day comment period and have indicated that they will work with the authors to try to come up with an effective solution.

CEQA streamlining is not a new issue to the Legislature, as there are bills just about every year that try to streamline the process. Senator Jerry Hill (D- San Mateo), a co-author of SB 122, tried to pass a CEQA reform bill in 2014 and former Senator Darrel Steinberg (D- Sacramento) tried in 2013, both to no avail.

ACWA is working on a CEQA reform bill with students from McGeorge Law School that would simplify the process for projects that have to issue notices in multiple counties. They have not released a specific bill yet.

Legislative Update

The Legislature returned to Sacramento on January 5. The month of January is generally slow with limited hearings allowing members to spend time organizing and working on legislation they intend to introduce.

Bill introductions have only begun to trickle in with legislators expected to introduce many more in the days leading up to the February 27 bill introduction deadline.

Bills IEUA is tracking to date:

AB (Brown D) Drought: local governments: fines.

Introduced: 12/1/2014

Summary: Would prohibit a city, county, or city and county from imposing a fine under any local maintenance ordinance or other relevant ordinance for a failure to water a lawn or having a brown lawn during a period for which the Governor has issued a proclamation of a state of emergency based on drought conditions.

AB 21 (Perea D) California Global Warming Solutions Act of 2006: emissions limit: scoping plan.

Introduced: 12/1/2014

Summary: Would require the State Air Resources Board, no later than January 1, 2018, to recommend to the Governor and the Legislature a specific target of statewide emissions reductions for 2030 to be accomplished in a cost-effective manner. This bill contains other related provisions and other existing laws.

AB 23 (Patterson R) California Global Warming Solutions Act of 2006: market-based compliance mechanisms: exemption.

Introduced: 12/1/2014

Summary: The California Global Warming Solutions Act of 2006 authorizes the State Air Resources Board to include the use of market-based compliance mechanisms. Current state board regulations require specified entities to comply with a market-based compliance mechanism beginning January 1, 2013, and require additional specified entities to comply with that market-based compliance mechanism beginning January 1, 2015. This bill would instead exempt those categories of persons or entities that did not have a compliance obligation, as defined, under a market-based compliance mechanism beginning January 1, 2013, from being subject to that market-based compliance mechanism through December 31, 2020.

AB 33 (Quirk D) California Global Warming Solutions Act of 2006: scoping plan. Introduced: 12/1/2014

Summary: The California Global Warming Solutions Act of 2006 requires the State Air Resources Board to prepare and approve a scoping plan for achieving the maximum technologically feasible and cost-effective reductions in greenhouse gas emissions. The act requires the scoping plan to be updated at least once every 5 years. This bill, until January 1, 2020, would require, for purposes of advising the update of the next scoping plan, the state board to develop specified information by July 1, 2016. The bill would require the state board on or before January 1, 2017, to submit a report to the appropriate committees of the Legislature on the specified information.

AB 45 (Mullin D) Household hazardous waste.

Introduced: 12/1/2014

Summary: Would express the Legislature's intent to enact legislation that would establish curbside household hazardous waste collection programs, door-to-door household hazardous waste collection programs, and household hazardous waste residential pickup services as the principal means of collecting household hazardous waste and diverting it from California's landfills and waterways.

AB 78 (Mathis R) Groundwater basins.

Introduced: 1/5/2015

Summary: Current law requires the Department of Water Resources to categorize each basin or subbasin as high-, medium-, low-, or very low priority and to establish ground water the initial priority for each basin no later than January 31, 2015. This bill would make technical, nonsubstantive changes to this provision.

AB 85 (Wilk R) Open meetings.

Introduced: 1/6/2015

Summary: Would, under the Bagley-Keene Open Meeting Act, specify that the definition of "state body" includes an advisory board, advisory commission, advisory committee, advisory subcommittee, or similar multimember advisory body of a state body that consists of 3 or more individuals, as prescribed, except a board, commission, committee, or similar multimember body on which a member of a body serves in his or her official capacity as a representative of that state body and that is supported, in whole or in part, by funds provided by the state body, whether the multimember body is organized and operated by the state body or by a private corporation. This bill contains other related provisions.

AB 88 (Gomez D) Sales and use taxes: exemption: energy or water efficient home appliances.

Introduced: 1/7/2015

Summary: Would exempt from sales and use taxes the gross receipts from the sale of, and the storage, use, or other consumption in this state of, an energy or water efficient home appliance purchased by a public utility that is provided at no cost to a low-income participant in a federal, state, or ratepayer-funded energy efficiency program for use by that low-income participant in the energy efficiency program. This bill contains other related provisions and other existing laws.

AB 140 (Allen, Travis R) Distributed generation.

Introduced: 1/9/2015

Summary: Current law require the Public Utilities Commission, on or before January 1, 2010, and biennially thereafter, in consultation with the Independent System Operator and the State Energy Resources Conservation and Development Commission, to study, and submit a report to the Legislature and the Governor, on the impacts of distributed energy generation on the state's distribution and

transmission grid. This bill would make a technical, nonsubstantive revision to this requirement.

AB 149 (Chávez R) Urban water management plans.

Introduced: 1/15/2015

Summary: The Urban Water Management Planning Act requires an urban water supplier to submit to the Department of Water Resources a copy of its urban water management plan and requires the department to prepare and submit to the Legislature, on or before December 31, in the years ending in 6 and 1, a report summarizing the status of plans adopted pursuant to the act. This bill, commencing January 1, 2017, would instead require an urban water supplier to update its plan at least once every 5 years on or before December 31 in years ending in 6 and one. The bill would instead require the department to submit its report to the Legislature, on or before December 31, in years ending in 7 and two.

AB 152 (Bigelow R) Water rights: appropriation.

Introduced: 1/15/2015

Summary: Under current law, the State Water Resources Control Board administers a water rights program pursuant to which the board grants permits and licenses to appropriate water. Current law requires the board to allow the appropriation for beneficial purposes of unappropriated water under terms and conditions as in its judgment will best develop, conserve, and utilize in the public interest the water sought to be appropriated. This bill would make a technical, nonsubstantive change to these provisions.

AB 153 (Bigelow R) Integrated regional water management planning.

Introduced: 1/15/2015

Summary: Current law authorizes a regional water management group to prepare and adopt an integrated regional water management plan with specified components. This bill would make a technical, nonsubstantive change to that provision.

AB 156 (Perea D) California Global Warming Solutions Act of 2006: investment plan.

Introduced: 1/20/2015

Summary: Current law requires the California Environmental Protection Agency to identify disadvantaged communities and requires the Department of Finance, in consultation with the state board and any other relevant state agency, to develop, as specified, a 3-year investment plan for the moneys deposited in the Greenhouse Gas Reduction Fund. This bill would require the department to include in the 3-year investment plan an allocation to provide technical assistance to disadvantaged communities to assist them in proposing specified projects for inclusion in the 3-year investment plan.

AB 168 (Maienschein R) Local government finance.

Introduced: 1/22/2015

Summary: Current law requires the county auditor, in the case in which a qualifying city becomes the successor agency to a special district as a result of a merger with that district as described in a specified statute, to additionally allocate to that successor qualifying city that amount of property tax revenue that otherwise would have been allocated to that special district pursuant to general allocation requirements. This bill would make nonsubstantive changes to the provision pertaining to property tax revenue allocations to a qualifying city that merges with a special district.

AB 197 (Garcia, Eduardo D) Public utilities: renewable resources.

Introduced: 1/28/2015

Summary: Would state the policy of the state to require all retail sellers of electricity, including investor-owned electrical corporations and local publicly owned electric utilities, to procure all available cost-effective, reliable, and feasible energy efficiency, demand response, and renewable resources, so as to achieve grid reliability and greenhouse gases emission reductions simultaneously, in the most cost-effective and affordable manner practicable. The bill would require that procurement not be limited by any targets established for these resources by statute or regulatory decision. This bill contains other related provisions and other existing laws.

SB 1 (Gaines R) California Global Warming Solutions Act of 2006: market-based compliance mechanisms: exemption.

Introduced: 12/1/2014

Summary: The California Global Warming Solutions Act of 2006 authorizes the State Air Resources Board to include the use of market-based compliance mechanisms. Current state board regulations require specified entities to comply with a market-based compliance mechanism beginning January 1, 2013, and require additional specified entities to comply with that market-based compliance mechanism beginning January 1, 2015. This bill instead would exempt categories of persons or entities that did not have a compliance obligation, as defined, under a market-based compliance mechanism beginning January 1, 2013, from being subject to that market-based compliance mechanism.

SB 5 (Vidak R) California Global Warming Solutions Act of 2006: market-based compliance mechanisms: exemption.

Introduced: 12/1/2014

Summary: Under the California Global Warming Solutions Act of 2006, current State Air Resources Board regulations require specified entities to comply with a market-based compliance mechanism beginning January 1, 2013, and require additional specified entities to comply with that market-based compliance mechanism beginning January 1, 2015. This bill instead would exempt categories

of persons or entities that did not have a compliance obligation, as defined, under a market-based compliance mechanism beginning January 1, 2013, from being subject to that market-based compliance mechanism through December 31, 2020.

SB 7 (Wolk D) Housing: water meters: multiunit structures.

Introduced: 12/1/2014

Summary: Would express the intent of the Legislature to encourage the conservation of water in multifamily residential rental buildings through means either within the landlord's or the tenant's control, and to ensure that the practices involving the submetering of dwelling units for water service are just and reasonable, and include appropriate safeguards for both tenants and landlords. This bill contains other related provisions and other existing laws.

SB 13 (Pavley D) Groundwater.

Introduced: 12/1/2014

Summary: Would provide a local agency or groundwater sustainability agency 90 or 180 days, as prescribed, to remedy certain deficiencies that caused the State Water Resources Control Board to designate a groundwater basin as a probationary basin. This bill would authorize the board to develop an interim plan for certain probationary basins one year after the designation of the basin as a probationary basin. This bill contains other related provisions and other existing laws.

SB 20 (Pavley D) Wells: reports: public availability.

Introduced: 12/1/2014

Summary: Current law requires a person who digs, bores, or drills a water well, cathodic protection well, or a monitoring well, or abandons or destroys a well, or deepens or reperforates a well, to file a report of completion with the Department of Water Resources. Current law prohibits those reports from being made available to the public, except under certain circumstances. This bill would instead require the department to, upon request, make the reports available to the public. The bill would require the department to provide specified disclaimers when providing the reports to the public.

SB 32 (Pavley D) California Global Warming Solutions Act of 2006: emissions limit.

Introduced: 12/1/2014

Summary: Would require the State Air Resources Board to approve a statewide greenhouse gas emission limit that is equivalent to 80% below the 1990 level to be achieved by 2050, as specified. The bill would authorize the state board to adopt interim greenhouse gas emissions level targets to be achieved by 2030 and 2040. The bill also would state the intent of the Legislature for the Legislature and appropriate agencies to adopt complementary policies that ensure long-term emissions reductions advance specified criteria.

SB 113 (Galgiani D) Disaster Preparedness and Flood Prevention Bond Act of 2006.

Introduced: 1/13/2015

Summary: The Disaster Preparedness and Flood Prevention Bond Act of 2006 authorizes bonds in the amount of \$4,090,000,000 for the purposes of financing disaster preparedness and flood prevention projects. Funds provided by the act are only available for appropriation until July 1, 2016, and at that time the amount of indebtedness authorized by the act is reduced by the amount of funds that have not been appropriated. This bill would remove the restriction that the funds are available for appropriation only until July 1, 2016.

SB 122 (Jackson D) California Environmental Quality Act: record of proceedings.

Introduced: 1/15/2015

Summary: CEQA establishes a procedure for the preparation and certification of the record of proceedings upon the filing of an action or proceeding challenging a lead agency's action on the grounds of noncompliance with CEQA. This bill would require the lead agency, at the request of a project applicant and consent of the lead agency, to prepare a record of proceedings concurrently with the preparation of a negative declaration, mitigated negative declaration, EIR, or other environmental document for projects. This bill contains other related provisions.

SB 127 (Vidak R) Environmental quality: Water Quality, Supply, and Infrastructure Improvement Act of 2014.

Introduced: 1/20/2015

Summary: CEQA establishes a procedure by which a person may seek judicial review of the decision of the lead agency made pursuant to CEQA and a procedure for the preparation and certification of the record of proceedings upon the filing of an action or proceeding challenging a lead agency's action on the grounds of noncompliance with CEQA. This bill would require the public agency, in certifying the environmental impact report and in granting approvals for projects funded, in whole or in part, by Proposition 1, including the concurrent preparation of the record of proceedings and the certification of the record of proceeding within 5 days of the filing of a specified notice, to comply with specified procedures.

SB 143 (Stone R) Diamond Valley Reservoir: recreational use.

Introduced: 1/27/2015

Summary: Current law, with certain exceptions, prohibits recreational use, in which there is bodily contact with water, in a reservoir in which water is stored for domestic use and establishes water standards for those exempted reservoirs. This bill would exempt from this prohibition recreational activity in which there is bodily contact with water by any participant in the Diamond Valley Reservoir if certain standards are met. This bill contains other related provisions.

Snapshot. Nationally, January marked the beginning of the last two years of the Obama Administration. It also marked the opening of the 114th Congress in which balance of power shifted as, for the first time during the Obama Presidency, the House and Senate are now both controlled by Republican majorities. In California, the weather whiplash continued. The temperature was hot *and* it did not rain. Drought continues.

114th Congress Convenes

New Congress Sworn In, Begins Process of Organizing Begun. In early January, the new Congress convened, was sworn in and the process of organizing – naming chairs, affirming committee jurisdictions, naming members to committees, selecting subcommittee chairs began and continued throughout the month. In one instance, a Subcommittee of importance to IEUA was jurisdictionally restructured (House, Water and Power – more on that – see below).

President Obama Appears Before Joint Session of Congress - Delivers State of the Union.

Sixth Obama State of the Union Speech. A reinvigorated President appeared before Congress and delivered his sixth State of the Union address. During the first six years of the presidency, the President vetoed very few bills (unlike his predecessors). The President made it clear – he would veto authorization and/or funding bills with which he disagreed. He challenged the Republican-controlled Congress to work with him. And, new initiatives on tax reform were presented. Internationally, he changed policy towards Cuba (no one saw it coming).

Looking Into February - President's Budget to be Released.

- Proposed Administration Budget to be Submitted to Congress in early February. Typically, immediately after the President delivers the State of the Union, the Administration's proposed budget for the fiscal year beginning next October 1 and running through September 30, 2016 is submitted to Congress. That submission is scheduled for the first week of February. January was used to preview the soon-to-be-released budget. In the speech to Congress, numerous other public events and news accounts, the the Obama Administration detailed the up-coming budget and outlined major initiatives on tax reform (taxing offshore income), income inequality, climate change, energy policy and the need for infrastructure investment.
- Spending Limits to be Challenged. The Obama budget, based on statements and various reports, is expected to challenge the Congress on budget caps with targeted and selected increases that go significantly beyond sequestration-agreed spending caps. DOD is publicly making a case for increased military funding/spending (and has been for some time). It is expected to

International Issues Continue to Dominate and Influence

- Immigration, Oil Prices, Syria, the Mideast, International Cyber Crime All Continue to be Major Issues. A suite of international issues continue to dominate and influence events around the globe and each becomes important domestically and in Congress. Immigration is grid-locked in Congress. The executive initiative by the President has created a significant backlash among some in Congress which is slated to play out in February in the one unresolved funding bill for the current fiscal year the appropriations bill for the Department of Homeland Security. Some are calling for another shutdown (if it were to occur, it would be limited to DHS and its agencies).
- Consumer Boon in US. Oil prices continue to drop from a high of \$107/barrel to \$40-50/barrel (current range). The abrupt oil price free-fall is destabilizing Putin and Russia, Iran, Syria and even selected countries in South America. In the US, the price of oil is upsetting production in North Dakota (the Bakken) and is forcing producing wells to shut down even in Texas and Oklahoma. Meanwhile, US consumers across the board are enjoying a large stimulus (this puts something like almost \$1 billion a day back into the economy across the US). Various industry sectors (airlines, trucking, buses, heating oil –

even cabs) are watching energy costs decline and profits increase. I recently bought gas in the DC area for less than \$2/gallon. On a recent trip to Minnesota (the temperature was MINUS 13 degrees when I landed), I paid \$1.86/gallon.

Mideast Conflicts Continue. The Mideast – in numerous places – continues to be unstable, contentious and seemingly on the verge of armed conflict. As January came to a close, armed conflict in the Ukraine with Russia was resuming. Civil and tribal war, and, in general, political chaos continues in Syria and acts of wanton terrorism continued unabated. Collectively, all these issues (and others) continue to compete for time, attention, funding priorities as well as policy formulation and implementation.

2016 - Presidential Politics Burst onto Scene.

- 2016 President Election Underway. The November 2012 election followed by the start of the new Congress marked the "public" beginning of the 2016 presidential election cycle.
- Republican Sweepstakes for President More than 20 Hats in the Ring. On the Republican side, more than 20 prospective candidates have emerged from the US Senate (Rubio, Cruz, Rand Paul, Lindsay Graham), the Governors (Walker from WI, Pence from Indiana, Jindal from Louisiana, Christie from New Jersey and others) and several from the business community (former Governor Jeb Bush) are actively considering formal entry into the process. Former Governor Huckabee is running as is former Pennsylvania Senator -- Rick Santorum. In January, Governor Jeb Bush all but formally announced (it caught everyone by surprise). January saw former 2012 presidential candidate and former Governor Romney began to reenter the race and after three weeks of bruising responses, dropped out before he formally re-entered.
- Democratic Sweepstakes for President It's All About Hilary Clinton. On the Democratic side, all eyes are on Hilary Rodham Clinton. A formal announcement is expect in April or May. If she doesn't run, it's not obvious who will.
- Polling, Sunday Talk Shows, Pundits, Columnists, Bloggers, Funders, Donors and Campaign Operatives All Hyper-Focused on 2016. Airwaves are already clogged with stories, hypothetical polling match ups and other speculative reporting about 2016. The more attention directed to 2016, the less is focused on current events today.

Drought and Drought Legislation/Drought Politics/Congress

Drought. Daily reports range between bleak and dire. Photos of the DWR team that measured snow pack at the end of January shows them walking (in the Sierras, on dry (no snowpack to measure) areas. San Francisco, for the first time in recorded history (going back to the Gold Rush) had 0.00 inches of rain. No rain whatsoever. At the same time, during the month of December, California was exceptionally hot – with almost no precipitation in the State during the month of January. If this continues, then the Governor's call for 20% reductions will all but certainly have to be reconsidered.

- **Drought Legislation**. Talks on a drought bill resumed behind closed doors and with limited participants. Talks blew up in a series of rolling events and actions during this past November and December. Others are now clamoring to be included. The House Natural Resources Committee has signaled that a California-only bill will likely NOT be considered, but a Westwide or even national bill will be. No details have emerged on such a bill or even the process for drafting it.
- Drought Politics House Water and Power Subcommittee Jurisdiction Expanded Implications for Bureau of Reclamation (and US Geological Survey). The Subcommittee that had jurisdiction for the Bureau of Reclamation and water/drought policy was restructured to include Oceans (and OCS drilling). This change diminishes the importance of the Bureau of Reclamation. A non-westerner, Rep. John Flemming (R-LA) was named Chair. First time a non-westerner chaired the subcommittee as far back as I can remember. Implications remain unclear.
- Drought Politics Congress (and Ds on House Water Subcommittees). For more than a decade, Rep. Grace Napolitano (D-CA) either Chaired the Water Subcommittee on House Resources OR served as its Ranking Member. In that period, she's worked with several California Rs who served as Chair, including Rep. Ken Calvert. In this Congress, Rep. Napolitano became eligible to serve as ranking on the Water Subcommittee on T&I which has jurisdiction over the Army Corps of Engineers as well as ranking on Water and Power on Resources. She selected the ranking position on Water Subcommittee on T&I in late January. Replacing her on the Water Subcommittee on Natural Resources, Rep. Jared Huffman (D-CA) who represents Marin County and the North Coast to Oregon. Huffman served as Chair, Assembly Water Committee when he served in the State Legislature.
- **Drought Politics** − **Blame**. In mid-January, House Majority Whip, Kevin McCarthy (R-CA) and CA Senator Barbara Boxer got into a public spat over who was to "blame" for the drought bill's demise in the previous congress. Not constructive (especially since any drought bill will be subject to being redrafted for multiple reasons (many who were excluded are now asking to participate − a new bill will likely be a westwide bill).
- Drought Conditions California. The precipitation from several storms in December came and went. In January. It was dry. According to the Drought Monitor, 100% of the State is in drought. The Monitor's weekly report for January 27 (reported on the 29th) indicated that 94% of the entire state was in D2, D3 and/or D4 status (severe, extreme or exceptional).
- **Drought Conditions** − **Rest of the West**. The report from last month − is all but identical this month. Drought conditions are persisting in the Pacific Northwest (OR, WA and ID). Almost all of OR is in drought. Half of Washington is in drought (less severe). Almost all of Idaho is in drought. Next door, 100% of Nevada is in drought (very similar to CA's profile). Along the Southern Tier, Arizona, New Mexico, Utah, most of Colorado and

almost all of Texas and Oklahoma are in various levels of drought. .

Quick Takes. Napolitano-Boxer water bill reintroduced in the new Congress. In the first days of the new session, Rep. Grace Napolitano reintroduced her comprehensive water bill with several co-sponsors. Last session, Rep. Napolitano asked that her bill be incorporated into the pending drought bill (it wasn't). She wasted no time in its reintroduction. Torres Joins Napolitano on Water bill. Rep. Norma Torres, in one of her first acts, co-sponsored the Napolitano water bill. **DWR Monthly Snowpack Report**. On January 29, DWR reported that, statewide, snowpack was 25% of normal. Senate Appropriations Organized. Energy and Water Subcommittee, Sen. Lamar Alexander (R-TN) will serve as Chair and Sen. Dianne Feinstein (D-CA) will serve as Ranking Member. On Senate Interior Appropriations Subcommittee (which includes funding for EPA), Sen. Lisa Murkowski (R-AK) will be chair. Senator Tom Udall (D-NM) will serve as Ranking Member. Standard and Poor's Issued a Caution Warning on Increased State Spending. According to a news account on the S&P report, "For California, a future revenue slump isn't only possible, it's expected," the credit rating agency Standard & Poor's said in a report. An over-optimistic assessment of the state's future revenue growth, the report said, would be "the most significant identifiable threat to the state's ongoing fiscal recovery." Colorado Issuing Stark Warnings to California on Colorado River Water. State water officials in Colorado delivered a draft water report to the Governor and publicly issued warnings to California (regarding future use of Colorado River water). News accounts label it "a threat." It's created growing tension in the Basin. A final report is due towards the end of 2015. In the past, on a semi-unrelated issue, AZ, NV and CA have paid for the Colorado River Salinity Act but are now talking about this becoming an all-basin responsibility (financially). Upper Basin states don't like it. Again, tensions are rising. If drought conditions persist, these issues could get lumped together and become even more contentious. BuRec Call for WaterSmart Proposals. Last month, BuRec issued a call for WaterSmart Proposals for basin-wide studies, with a focus on climate disruption and adaptation strategies. \$50 Billion Infrastructure Bill Reintroduced. Rep. John Delaney (D-MD) reintroduced bi-partisan legislation to fund a \$50 Billion infrastructure fund (including money for water-related projects). President, in State of the Union, Calls for Infrastructure Bonds. In his State of the Union Address, the President called for tax-exempt bond funding for capital investments in communities. This was viewed as especially positive as Muni Bond are targeted for amendment and restrictions in several of the pending tax reform bills.

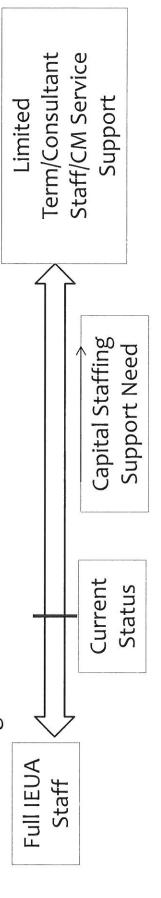

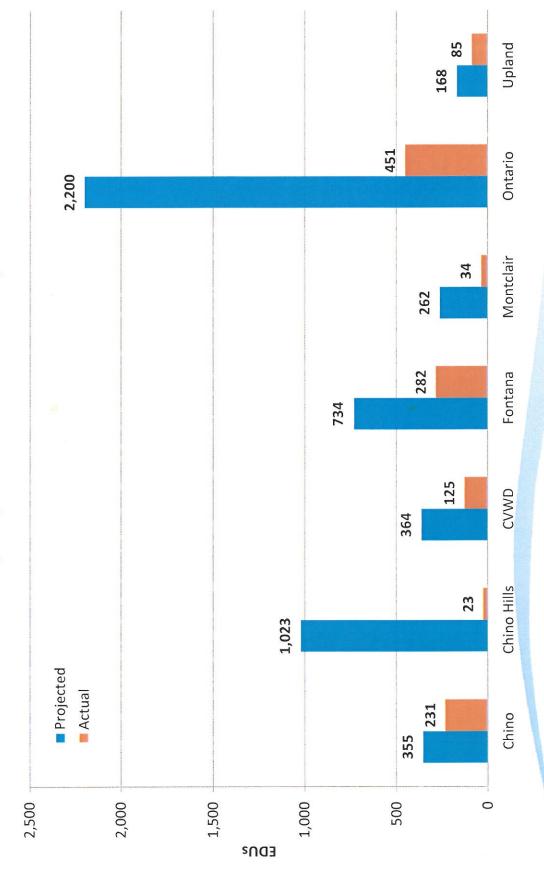

(July - December 2014)

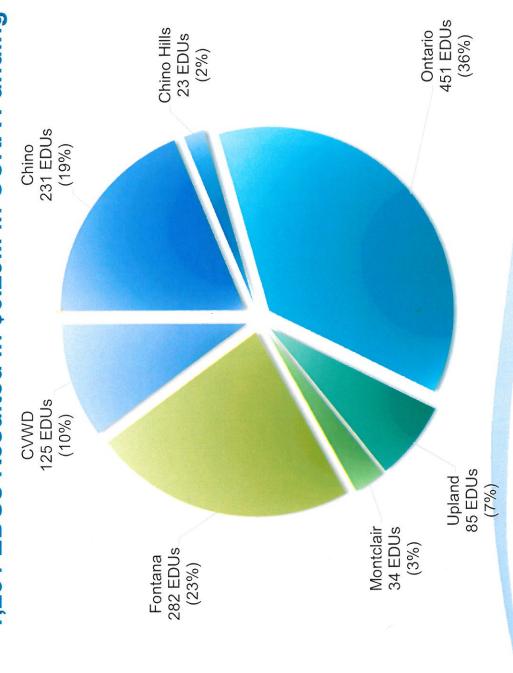


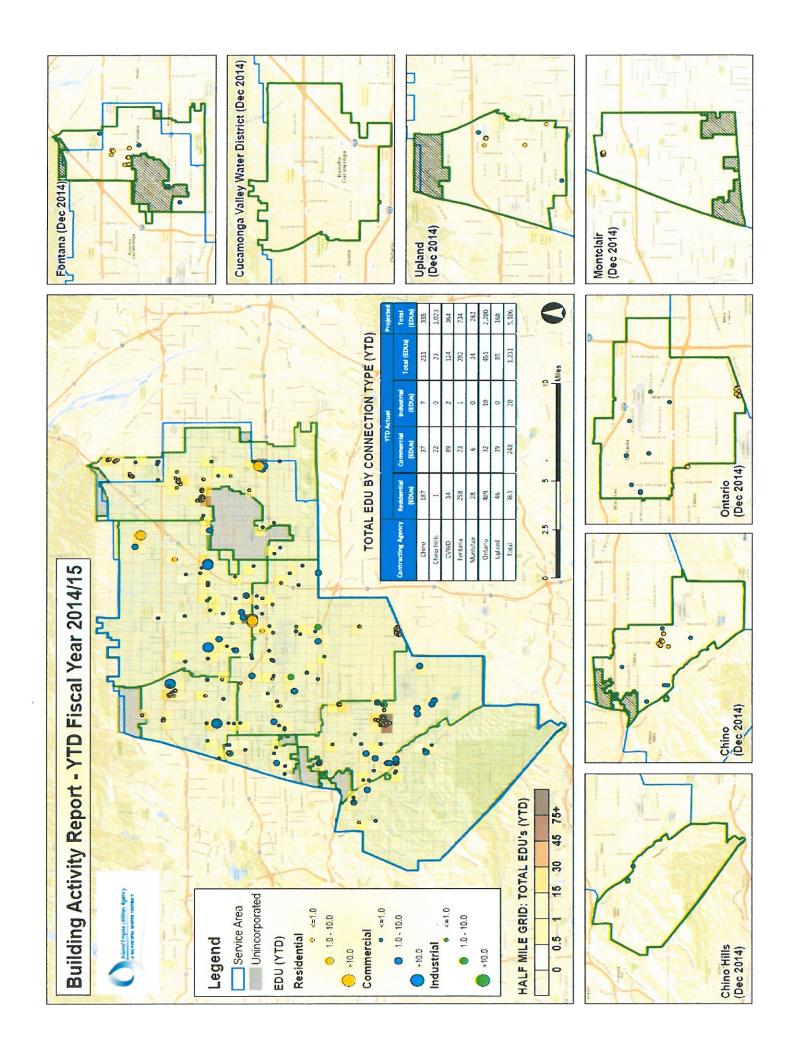

OPERATIONS UPDATE

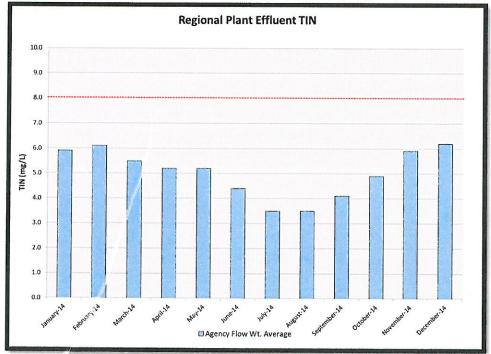

IERCF UPDATE

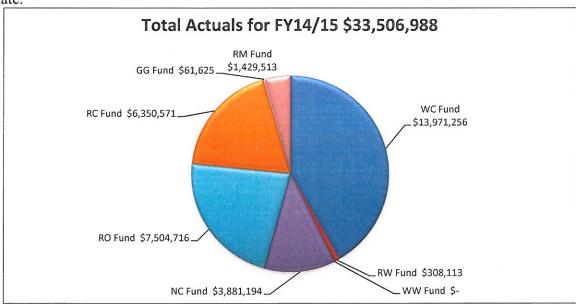

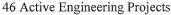


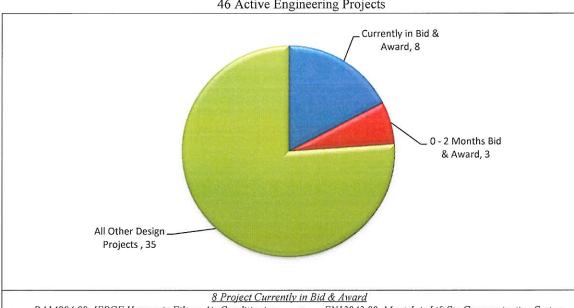

RECOMMENDATION

It is recommended that the Board of Directors:

- 1. Approve and adopt the recently completed classification and compensation study for all Laboratory Unit employees;
- 2. Approve the modification of various position titles for all Laboratory Unit employees, as a result of the adoption of the classification and compensation study; and
- 3. Adopt Resolution No. 2015-2-3 to amend the 2013 2018 Memorandum of Understanding (MOU) for the Laboratory Unit with a new Salary Matrix and Classification Plan based on the results of a classification and compensation study.

BACKGROUND

In November 2013, the Inland Empire Utilities Agency (the Agency) retained the services of an independent consultant Reward Strategy Group (RSG) to conduct an Agency-wide classification and compensation study (the Study). The last time a comprehensive study was conducted was in 1998. Since then, the Agency has made some modifications to classifications and salary schedules/matrices; however, a comprehensive review and update of the classification plan has not been completed.

The Agency's objective in retaining RSG to conduct the Study included the following: 1) ensure class specifications appropriately define core job responsibilities, level of complexity, accountability, performance expectations and essential qualifications, 2) provide salaries

commensurate with assigned duties, 3) outline promotional opportunities, 4) provide reasonable and justifiable pay differential between classes to ensure internal equity 5) maintain currency with relevant labor markets, and 6) consolidation of seven salary matrices into a single matrix for all Agency employees.

The Study provided a recommendation for a revised classification structure including new class specifications, job titles, and salaries along with revised Fair Labor Standards Act (FLSA) designations (i.e. exempt vs. non-exempt status). This report only addresses the proposed changes for the Laboratory Unit. The Board of Directors (the Board) previously adopted the changes for all Unrepresented employees at its Board meeting on January 21, 2015. A recommendation will be presented to the Board for all other represented employees upon completion of the meet and confer process with the respective bargaining units.

As part of the analysis, RSG reviewed all existing class specifications and all position description questionnaires completed by each individual employee, along with their supervisor's supplemental questionnaire. In some cases, RSG also interviewed the employee and supervisor individually to obtain clarification on duties performed. A total of 147 employees were interviewed. RSG utilized this information to submit draft class specifications for all positions along with recommended allocations of current positions into the new classifications. The draft class specifications were then distributed to all employees and their respective managers. All employees were given an opportunity to provide their feedback on the proposed class specifications and submit a request for reconsideration if they felt that they were improperly classified. A total of 120 reconsideration requests were submitted. The feedback was then reviewed by RSG, the Executive Managers, and Human Resources in order to determine if any changes were warranted. The new class specifications for all Laboratory Unit employees will be posted on the Agency's intranet website upon the Board's adoption of Resolution No. 2015-2-3.

Once the class specifications were finalized, RSG conducted a survey using 19 comparable agencies (including cities and municipal water agencies) and 54 benchmark positions; 2 positions from the Laboratory Unit. RSG then made recommendations for salaries based on the following criteria: benchmark data comparison (labor market survey), complexity of the job, internal/external value of the job (i.e. recruitment and retention value), internal equity, educational and certification requirements. A key objective of the Study was to consolidate the various salary matrices for the represented and unrepresented groups. The new consolidated salary schedule/matrix for all Laboratory Unit employees and Unrepresented employees, is included as "Exhibit 1" of Resolution No. 2015-2-3. It is anticipated that at the conclusion of the meet and confer process with the other represented groups, the Agency can move forward to implement a single consolidated salary schedule/matrix for all employees. Exhibit 1 of Resolution No. 2015-2-3 also includes a listing of the hourly, bi-weekly, monthly and annual amounts by step (1-9) for each of the proposed salary ranges.

The salary analysis portion of the Study resulted in recommended increases for most positions. To the extent any classifications within the Laboratory Unit were below the average for comparable agencies pursuant to the Study, a recommendation is being made to provide to employees in such classifications a one-time pay increase sufficient to place the employee at the salary step closest to,

and not to exceed, 5.0% of the employee's current base salary. In some instances, the employee's salary will need to be adjusted using a higher percentage increase to place them in the bottom step (Step 1) of the new salary range. This is consistent with the methodology negotiated with the General Unit and what is being proposed to all other represented units. Attachment 1 provides a comparison of the average change by classification of the current and proposed salary range at the top level (Step 9). Per the study, no positions in the Laboratory were identified as being above the average.

Since the Study encompassed a review of total compensation (wages and benefits), RSG also collected market survey data on employee benefits from the 19 comparable agencies to ensure that the Agency's benefit package is comparable. RSG's survey found the Agency's benefit plan to be competitive in the labor market; therefore, no recommendation was made to enhance the Agency's benefit plan.

If approved, all the proposed changes as outlined in this report shall be effective retroactively to November 1, 2014.

The approval of the results of the class and comp study is consistent with the Agency's *Workplace Environment* business goal to be committed to providing a positive workplace environment by recruiting, retaining and developing a highly skilled team dedicated to the Agency's Mission, Vision, and Values.

PRIOR BOARD ACTION

On January 21, 2015, the Board of Directors adopted Resolution No. 2015-1-4 Amending the Personnel Manual, Salary Matrix, and Classification Plan for All Unrepresented Employees, including Executive Management.

On May 21, 2014, the Board of Directors adopted Resolution No. 2014-5-15, approving an amendment of the Laboratory Unit employees' salary schedule/matrix.

On September 4, 2013, the Board of Directors adopted Resolution No. 2013-9-1, approving the Memorandum of Understanding for Laboratory Unit employees.

IMPACT ON BUDGET

The one-time salary adjustment retroactive to November 1, 2014 for the Laboratory Unit employees, is estimated to be \$16,000. Funding for the class and comp study is appropriated in the FY 2014/15 Budget under the Administrative Services (GG) Fund.
