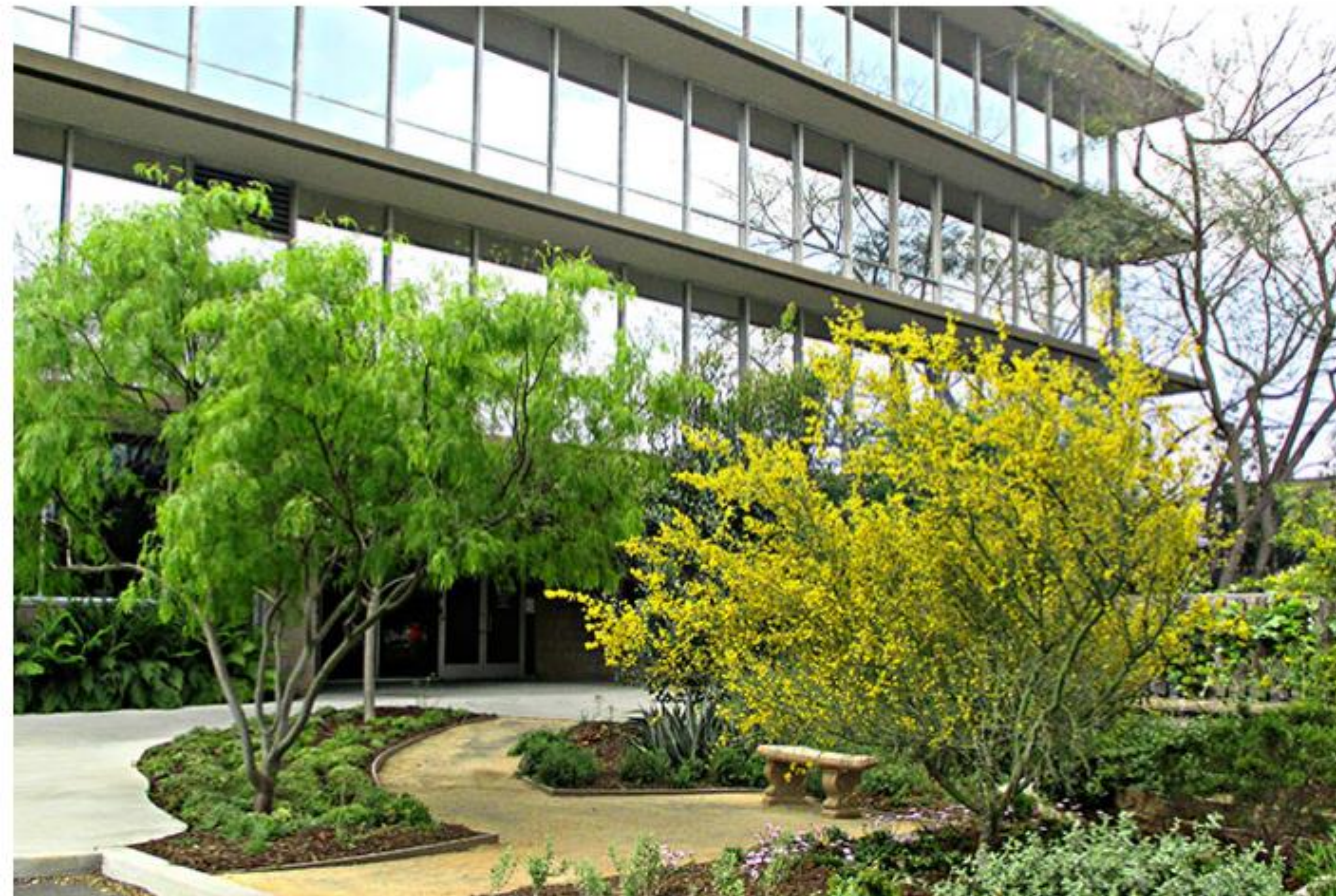

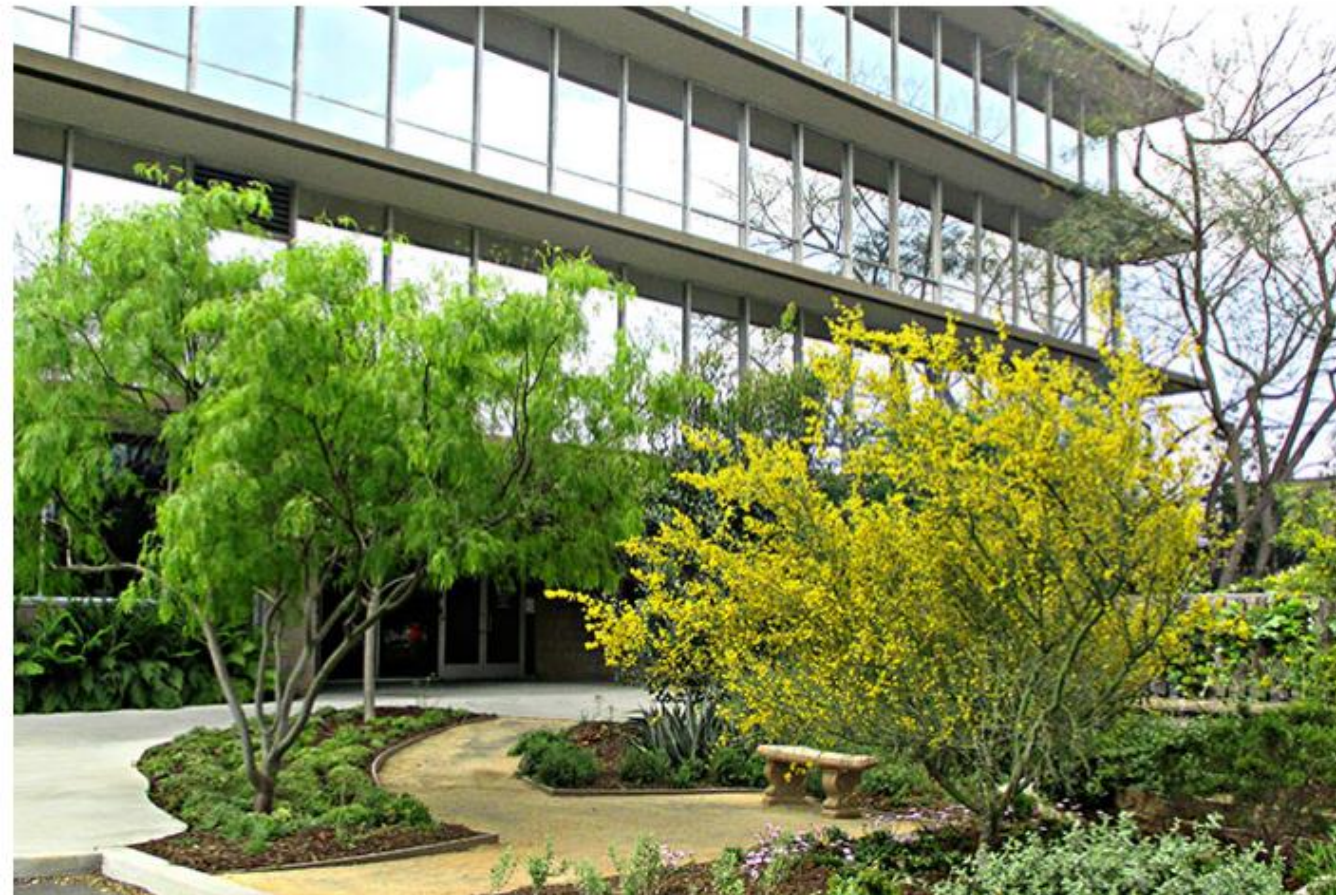

New Terms for Commercial Turf

The Turf Removal Program has re-launched with new terms and conditions, effective for all new and pending applications.

Commercial turf removal customers may now apply for and receive \$1 per square foot, up to \$25,000 per property each fiscal year (July 1-June 30). Commercial customers who previously received a turf removal rebate may apply for a rebate for additional areas. However, each property is subject to a maximum of \$25,000 per fiscal year.

Public agencies may apply and receive \$2 per square foot for the first 3,000 square feet, and \$1 for each square feet of turf removed thereafter, up to a maximum of \$50,000 per property each fiscal year (July 1 - June 30). Public agencies who previously received a turf removal rebate may apply for additional areas. However, each property is subject to a maximum of \$50,000 per fiscal year.

For purposes of the Turf Removal Program, "public agency" shall mean any county, city, whether general law or chartered, municipal corporation, town, school district, special district or water district that is located within the geographic areas served by the Metropolitan Water District of Southern California (Metropolitan). "Public agency" also shall include any state agency, department or division, to the extent it is situated on property that is located within the geographic areas served by Metropolitan. "Public agency" shall not include any for profit, non-profit, not-for-profit, mutual benefit, public benefit or quasi-public entity or corporation.

Public agencies who previously received a turf removal rebate may apply for a rebate for additional areas. Thank you for submitting your turf reservation waitlist application. Your application has been placed on a waitlist and will be reviewed in the fall should additional funds become available. Please note that submittal of this application does not guarantee funding.

Customers on the waitlist who are selected and approved for a reservation will receive an email in November. If you would like to be considered for a rebate, you must not start your project until after you receive an email confirming you have been selected.

Submittal of a reservation request or application does not guarantee approval or payment.

Required Terms and Conditions to be eligible for a rebate:

- Not include any live turf or turf-looking grasses
- Include some plants (excluding turf) in the project area
- Be permeable to air and water to reduce surface water runoff. Areas with concrete, structures and other surfaces that water and air cannot move through will be disqualified.
 - Turf areas replaced with structures or any impermeable surfaces will not be eligible for the rebate.
(Please exclude these turf areas from your measurements to avoid program disqualification)
 - Some examples of built structures include: raised patios, decks, and garages
 - Pathways with broken concrete, flagstone, or other like materials may be used, but cannot be filled in with cement

Customers are responsible for complying with all applicable laws, codes, policies, covenants, conditions, and restrictions.

1. Rebate amounts vary by water agency and are subject to change at any time.
2. Renters may be eligible to participate with written consent of property owner. Renter's name must be on water bill.
3. All rebated devices are subject to on-site inspection.
4. Metropolitan and participating water agencies are not responsible for any taxes, fees or tariffs that may be imposed as a result of device purchase.
5. Metropolitan and participating water agencies make no representation or warranty relating to devices, including any hazardous substances that may be contained in the device. This application form is for rebate purchases only.
6. Applicant waives and releases Metropolitan, participating water agencies, and their contractors or agents from any and all claims and causes of action arising out of the installation and use of devices pursuant to the Turf Removal Rebate Program.
7. If installation cannot be verified, the applicant must reimburse Metropolitan for rebates received and associated processing costs.
8. Reduced water bill is not guaranteed.
9. Email address may be used to communicate additional available rebates or programs.
10. Limit one rebate application per product category, per address. If you have already received a rebate through your water service provider for a qualifying device, you may not apply again for the same product category.
11. Rebate checks will become void 90 days after being issued.
