RECOMMENDATION

It is recommended that the Board of Commissioners:

- 1. Adopt Resolution No. 2017-1, authorizing the President of the Authority to sign and file a Financial Assistance Application for an assistance agreement from the State Water Resources Control Board (SWRCB) for the planning, design, and construction of the Storm Water Management Facilities;
- 2. Adopt Resolution No. 2017-2, authorizing the President of the Authority to sign and file the State Revolving Fund (SRF) loan application and agreement with the SWRCB for the planning and design of the Recharge Master Plan Update (RMPU) projects;
- 3. Adopt Resolution No. 2017-3, designating the grant Project Director; and
- Authorize the President of the Authority to sign the Designation Letter. 4.

BACKGROUND

STORMWATER GRANT PROGRAM:

The SWRCB administers the Proposition 1 (Prop 1) Storm Water Grant Program (SWGP) for projects that have multiple benefits due to better storm water management. In December, 2015, the SWRCB announced the SWGP grant opportunity. Approximately \$80 million of Prop 1 funds were made available under this round of the SWGP.

IEUA filed a pre-application in April 2016 on behalf of the Chino Basin Regional Financing Authority (CBRFA). IEUA was invited to submit a full application. The full application was Adoption of Resolution Nos. 2017-1 through 2017-3, for Recharge Master Plan Update Grant and Loan Applications January 18, 2017

submitted in November 2016. In December 2016, IEUA was notified that the project was selected to be awarded a \$10,000,000 grant.

The project is a collaboration between the IEUA and the Chino Basin Watermaster (CBWM). The funding will be used for the planning, design and construction of the Storm Water Management Facilities: Wineville, Jurupa and RP3 Basin (Project 23a).

STATE REVOLVING LOAN FUND PROGRAM

The CBRFA has also filed a Clean Water SRF Loan application for the planning and design of the RMPU Projects. The SWRCB requires a resolution authorizing the President of the Authority to apply for and execute funding agreements.

The SWRCB requires that the CBRFA adopt resolutions for both the grant and the SRF loan programs, authorizing the President of the Authority, or his designee, to sign and file financial assistance applications and execute the financial assistance agreements. In addition, to align with established IEUA procedures, it is requested that the CBRFA adopt a resolution designating the Grants Officer as the Project Director.

These projects demonstrate the integrated regional approach for groundwater supply optimization by meeting the region's need to develop reliable, drought-proof and diverse local water resources that reduce dependence on imported water supplies.

PRIOR COMMISSION ACTION

On May 18, 2016, the Commission approved Resolution Nos. 2016-4 and 2016-5 authorizing staff to submit the SRF loan application for the RMPU pre-design.

IMPACT ON BUDGET

The IEUA currently has a total project budget of \$58,413,000 in the Ten-Year Capital Improvement Plan for the RMPU projects. The \$10,000,000 Storm Water Grant Award, and the SRF loan will offset these costs.

ASSISTANT GENERAL MANAGERS

I also hereby designate the IEUA's Assistant General Managers (AGMs) the authority to sign all grant or SRF loan-related documents, as they are duly authorized by the Authority as signatories for grant and loan related documents.

GRANTS OFFICER

I also hereby designate IEUA's Grants Officer the authority to negotiate financial agreements and to sign grant or SRF loan related documents to implement the grant and loan agreements approved by the GM and/or AGMs, including but not limited to, reimbursement invoices, accompanying progress reports, project performance reports, project completion certifications, and cost certifications, requests for no costs extensions or reclassification of grant cost categories, etc.

These designations will not supersede but are in addition to those designations previously authorized by the Commission as signatories for grant and loan-related documents. In addition, these designations will remain in effect through Commission electoral changes and will only be rescinded if a letter rescinding these designations is authorized by the Authority's Commission President.


