Request to Store Water in the Chino Basin Conjunctive Use Program – Fiscal Year 2018-2019
and Fiscal Year 2019-2020

This letter is to request that your agencies store water under the Groundwater Storage Program Funding Agreement, also known as the Conjunctive Use Program (CUP) Agreement No. 49960 between the Metropolitan Water District of Southern California (Metropolitan), Inland Empire Utilities Agency (IEUA), Three Valleys Municipal Water District (TVMWD), and Chino Basin Watermaster. This action is consistent with the provisions of the CUP Agreement.


Under the CUP Agreement, Metropolitan may store up to 25,000 acre-feet per fiscal year into the Metropolitan Storage Account upon 15 days' notice. This letter formalizes Metropolitan's request that your agencies begin storing at maximum capacity into the Metropolitan Storage Account during fiscal years 2018-19 and 2019-20. At your earliest convenience, please provide your Annual Operating Plan, estimating the monthly schedule for increasing imported water deliveries at your service connections and method of delivery.
