





- What impact does groundwater pumping have on the river?






Opportunity to purchase flows from upstream agencies to meet Santa Ana River discharge obligations and increase recycled water use!

Santa Ana River Conservation & Conjunctive Use Program (SARCCUP)

- Santa Ana Watershed Project
- Increases supply reliability
- Total Project: \$100 Million
 - \$55M Grant, \$30M Local Cost Share
- 180,000 AF Groundwater Storage
- Habitat Improvement & Water Use Efficiency






SARCCUP: Current Recommended Project Scope

- 180,000 acre-feet total storage
 - Chino 50,000 AF (96,000 AF)
 - WMWD 10,500 AF
 - SBVMWD 64,000 AF
 - EMWD19,500 AF
 - OCWD 36,000 AF
- New wells and treatment
- Baseline Feeder Pipeline
- Service turnouts
- Rehab of wells





SARCCUP: Chino Basin Focus

What SARCCUP Provides

- \$16.5 Million for infrastructure (wells and treatment)
- Water Quality Improvement

What is needed to finalize SARCCUP commitment

- Need IEUA's member agencies participation for SARCCUP performance within Chino Basin
- Storage within Chino Basin for SARCCUP (50,000 AF)
- Purchase of 36,000 AF over the next 30 years

Executive Summary:

In August 2017, Inland Empire Utilities Agency (IEUA) submitted the Proposition 1 Water Storage and Investment Program (WSIP) grant application for the Chino Basin Environmental Water Program (CBEWP). To help develop and evaluate environmental and ecosystem benefits, GEI Consultants Inc. was retained by IEUA in June 2017. The initial contract was \$89,564. As the application was being developed, additional efforts were needed to fulfill the requirements of the grant application. Two separate amendments were issued and the contract amount was increased to \$145,664. In September, IEUA received confirmation that the submitted application met all eligibility and completeness requirements.

On January 9, 2018, IEUA was invited to attend a review meeting to discuss claimed public benefits with California Water Commission (CWC) staff. Feedback provided by the CWC will require additional work relating to the claimed environmental and ecosystem benefits. If approved, the total contract amount with GEI Consultants, Inc. would increase to \$227,664.

Staff's Recommendation:

- 1. Award an engineering services contract amendment to GEI Consultants, Inc., for a not-to-exceed amount of \$82,000; and
- 2. Authorize the General Manager to execute the contract subject to non-substantive changes.

CHINO BASIN ENVIRONMENTAL WATER PROGRAM

THIS CONTRACT AMENDMENT THREE is made and entered into this ______day of _______, 2018, by and between the Inland Empire Utilities Agency, a Municipal Water District, organized and existing in the County of San Bernardino under and by virtue of the laws of the State of California (hereinafter referred to interchangeably as "IEUA" and "Agency"), and GEI Consultants, Inc. of Woburn, MA (hereinafter referred to as "Consultant") for professional services related to Services for Proposition 1 Water Storage Investment Program (WSIP) Grant Application for Chino Basin Conjunctive Use & Environmental Water Storage/Exchange Program (e.g. Chino Basin Environmental Water Program), and shall revise the Contract as herein amended:

SECTION FOUR, SCOPE OF WORK AND SERVICES, ADDS THE FOLLOWING: Consultant's additional services and responsibilities shall include and be in accordance with the following:

Subsection F. Reference **Exhibit E** which is attached hereto, referenced herein, and made a part hereof.

SECTION FIVE, TERM, IS REVISED TO READ: The term of this Contract shall extend from the date of the Notice to Proceed and terminate on **December 31, 2018**, unless agreed to by both parties, reduced to writing, and amended to this contract.

SECTION SIX, PAYMENT, INVOICING, AND COMPENSATION, IS REVISED TO ADD THE FOLLOWING:

Subsection G. As compensation for the additional Work performed under this Contract Amendment, Agency shall pay Consultant a **NOT-TO-EXCEED MAXIMUM OF \$227,664.00** for all services satisfactorily provided during the term of this Contract. This reflects an additional \$82,000.00 as approved by Project Manager's SAP Purchase Requisition 10043376.

All Other Provisions Of This Contract Remain Unchanged, In Full Force, And Effect.

Dear Ms. Lee:

This letter is requesting amendment to GEI Contract #4600002389 (Contract) for Professional Services to aid in responding to California Water Commission (CWC) requests pertaining to the Inland Empire Utilities Agency (IEUA) Proposition 1 Water Storage and Investment Program (WSIP) Grant Application for the Chino Basin Environmental Water Program (CBEWP Grant).

This amendment is in response to IEUA's request to provide additional professional services based upon expected requests from the CWC to discuss IEUA's CBEWB Grant application during the CWC review period which is expected to continue through July 2018.

The requested amendment is as follows:

- Amend the contract price not-to-exceed from \$145,664 to \$227,664, an increase of \$82,000.
- Amend the scope of services to include the following work activities, which are to be performed on an as-needed basis upon direction from the IEUA Project Manager:
 - O Continue to assist IEUA with requests from the CWC to discuss IEUA's CBEWP Grant application. The type of support expected includes:
 - Revise the CBEWP Grant application physical benefits, monetization of benefits, and cost allocation as needed to address CWC review findings and comments and respond to the available appeals processes.
 - Complete additional alternatives analysis that would provide similar benefits as proposed in the CBEWP Grant application.
 - Complete QA/QC of the CBEWP Grant application materials.
 - Prepare and submit to CWC additional CBEWP Grant application materials developed by the above activities.
 - Support IEUA with planned CWC Proposition 1 WSIP Grant Application meetings, including pre-planning, materials preparation, attendance, and meeting notes summaries. This includes but is not limited to assisting IEUA with participating in three 3-day public meetings to be conducted by the CWC for presenting (i) CWC adjusted public benefit ratios for public review, (ii) CWC scores of Proposition 1 WSIP Grant applications, and (iii) CWC recommendations of awards of Proposition 1 WSIP Grant applications.
 - Hold technical team meetings with IEUA staff to coordinate the above activities.
 - O Assist IEUA with outreach to interested parties, project stakeholders, and project partners, including but not limited to:
 - Advancing partnership arrangements with key State Water Project Contractor agencies, Chino Basin Watermaster, and expected parties to the planned SAR recycled water supply acquisition.
 - Advancing institutional arrangements with other parties including CDFW, DWR, and SWPC.
 - Assist IEUA with further development and advancement of CBEWP Grant project components, as needed.

• Amend the term of the contract from June 30, 2018 to December 31, 2018.
