PUBLIC COMMENTS

There were no public comments.

1. TECHNICAL COMMITTEE REPORT

Derek Wieske/City of Montclair reported that the Technical Committee met on November 30, 2017, and approved all the action items unanimously. The Technical Committee was provided with an update on the septic feasibility study. Mr. Wieske then provided an update on item 3A — Regional Contract Renewal and stated that the facilitator will be providing a white paper in December. The facilitation team and the Technical Committee will be meeting for a special workshop on January 18 and a joint meeting will be scheduled for February.

2. ACTION ITEMS

A. APPROVAL OF THE MINUTES OF NOVEMBER 2, 2017 REGIONAL POLICY COMMITTEE MEETING

<u>Motion</u>: By Jim Bowman/City of Ontario and seconded by Trisha Martinez/City of Montclair to approve the minutes of the November 2, 2017 Regional Policy Committee meeting.

Motion carried: Unanimously with Peter Rogers/City of Chino Hills abstaining.

B. RP-5 AERATION DIFFUSER REPLACEMENT CONSTRUCTION CONTRACT AWARD

Shaun Stone/IEUA gave a presentation on the construction contract award for the RP-5 Aeration Diffuser Replacement Project. Mr. Stone stated that equipment was installed in 2004 and was partially replaced in 2011. Due to the aeration diffuser degrading, the diffusers have become less effective and the process has reduced performance and reliability, resulting in an increase in electricity usage. In addition to the panels, mechanical mixers and sprayer piping need to be replaced. IEUA received four bids on November 7, 2017. The lowest bid was from Genesis Construction for \$2,987,654. Mr. Stone then explained the discrepancy between the Engineer's estimate and bids. Mr. Stone requested that the Policy Committee recommend to the IEUA Board of Directors to award the construction contract to Genesis Construction in the amount of \$2,987,654.

<u>Motion</u>: By Jim Bowman/City of Ontario and seconded by Peter Rogers/City of Chino Hills to make recommendation to the IEUA Board of Directors to approve the construction contract for the RP-5 Aeration Diffuser Replacement to Genesis Construction in the amount of \$2,987,654.

Motion carried: Unanimously.

D. SEPTIC FEASIBILITY STUDY UPDATE

Ms. Tiegs inquired about the next steps for the septic feasibility study. Chris Berch/IEUA explained that the consultant developed and identified where septic opportunities are within the service area; a draft of that report will be provided within the next couple of months. Mr. Berch stated that IEUA provided a summary of the number of septic systems and cost for the conversions. Mr. Berch stated that the guidelines for Proposition 1 were released for water quality and added septic-to-sewer conversion. Ms. Martinez asked that IEUA present this item in the future at a City of Montclair Council meeting. Mr. Berch stated that IEUA will do that once the report is finalized.

5. OTHER BUSINESS

A. IEUA GENERAL MANAGER'S UPDATE

Halla Razak stated that she and Joseph Grindstaff will be presenting to the California Water Commission on December 13, for the Proposition 1 funding for storage. IEUA is requesting \$480 million.

C. COMMITTEE MEMBER COMMENTS

Ms. Tiegs asked if IEUA can add updates of legislative issues that impact water and bond issues to the Committee meetings. Ms. Razak responded that IEUA would be happy to do so.

1. INFORMATIONAL ITEMS

A. REGIONAL CONTRACT UPDATE/RENEWAL

Michael Harty, Dennis Diemer and Michael Rudinica (Facilitation Team) introduced themselves to the Regional Sewage Committees. Mr. Harty presented the same presentation (attached) that was presented to the Technical Committee on January 18, 2018. The Facilitation Team gave an overview of the following:

- Scope of work of Phase 1
- Current contract structure
- Findings and observations
- > Obstacles and challenges for a new agreement that were identified during the interviews
- Negotiation timeline (about 3-year process)
- Options that were identified in the assessment

Mr. Harty then discussed the three options and asked the Committees what they would like to do on negotiating this contract:

- Option A Defer negotiations until January 2, 2020
- Option B Pursue issue by issue negotiations as opportunities (scoping) and send out a schedule (3 to 4-year timeframe)
- Option C Invest resources in current negotiation initiative (2 to 3-year timeframe)

(Jim Bowman left the meeting room at 5:05 p.m.)

Mr. Armendarez asked if they want to do nothing. Luis Cetina recommended Option C with specific timelines and set goals for the Technical Committee to develop a third amendment addressing EDUs and recycled water within this year. Scott Burton stated that that Jim Bowman had to leave therefore, Ontario will not be voting. He stated there is no point in waiting. There is a lot to work on. It might be

prudent to layout and scope the issues and prioritize them, maybe start with Exhibit J. Halla Razak stated that at the Technical Committee on January 18, the Committee discussed tackling the easier issues.

Mr. Armendarez had recommended Option B and C, but then amended his motion to Option C and stated that the Technical Committee workout the scoping and bring it back to the Policy Committee with a timeframe. Ms. Martinez seconded.

RECOMMENDATION

It is requested that the Regional Committees recommend the IEUA Board of Directors award the construction contract for the design-build contract for the Napa Lateral, Project No. WR15021, to Ferreira Construction Company in the amount of \$5,332,122 with recognition that recycled water used for this project will not be from a member agency's base entitlement unless otherwise agreed.

BACKGROUND

In November 2015, IEUA coordinated with the City of Fontana (Fontana Water Company), California Steel Industries (CSI), and the Auto Club Speedway (Speedway) to provide recycled water for delivery to CSI and Speedway for industrial and irrigation use. In December 2015, IEUA submitted an application to the California State Water Resources Control Board (SWRCB) for financial assistance through the Proposition 1 Water Recycling funding program. In November 2017, IEUA received the notification from the SWRCB that the project was selected for financial assistance through a principal forgiveness of \$2,500,000 and a low interest loan.

The project consists of the design and construction of approximately 10,000 linear feet of 12-inch, 16-inch, and 24-inch pipelines along Napa Street and San Bernardino Avenue in the unincorporated area of San Bernardino County. Each lateral will connect to IEUA's existing recycled water transmission pipeline located along Etiwanda Avenue. It is anticipated that at least 500 acre-feet per year of recycled water usage will be obtained as a result of this project.

On December 13, 2017, a request for bids was advertised to the prequalified contractors. Several contractors participated in three pre-bid meetings held on December 19, 2017, January 9, 2018, and January 23, 2018. On March 15, 2018, the following four bids were received:

Ferreira Construction Company was the lowest responsive and responsible bidder with a final bid amount of \$5,332,122. The final bid amount was inclusive of the additive and deductive items stated in the bid forms. Ferreira Construction Company was pre-qualified for the project; presenting the required experience having performed similar projects with other utilities and cities and showing good workmanship and responsiveness. Additionally, Ferreira Construction Company has performed very successfully for IEUA on previous projects.








Key Drivers of the Fiscal Year 18/19 Ten Year Capital Improvement Plan




New Equivalent Dwelling Unit (EDU) Forecast (2017 Member Agency Forecast Data - Cumulative)

Major Treatment Facility Capacity/Expansion Project Estimated Treatment Plant Expansion Schedule







Kearns & West is pleased to submit this proposal for Phase 2A scoping services consistent with the direction provided by the Technical and Policy Committee at their February 1, 2018 Workshop. The Workshop concluded our Phase 1 services to IEUA and the Contract Agencies. In accordance with our Phase 1 Scope of Work, the Kearns & West team successfully developed an understanding of the current 50 year Regional Sewage Service Contract, completed in-depth interviews with IEUA and the seven Contract Agencies, and identified and categorized the issues needing to be updated or revised in the upcoming Contract negotiations. In addition to identifying numerous policy, technical, and administrative issues to be negotiated, the Kearns West team also identified several "qualitative" issues, such as trust and communications, that we believe also need to be improved in order to successfully complete negotiation of the Contract.

The Kearns & West team is proposing a Scoping Phase 2A wherein we will work with IEUA and the Contract Agencies to review, confirm and prioritize the issues identified in Phase 1. As part of the Phase 2A services we will also be reviewing the sequencing of the negotiations for the identified issues, looking for "easy wins" early on, and confirming the appropriate negotiation structure and approach. Finally, we will develop and confirm an overall schedule for completion of the entire negotiation process and identify the needed resource commitments from IEUA and the Contract Agencies.

The negotiation process envisioned for Phase 2B will be a multi-year process with significant time and resource commitments from all of the participating agencies. We believe the Phase 2A effort as more fully described in the attached Scope of Work is essential to making sure IEUA and the Contract Agencies have a common vision for Contract negotiation success, and fully understand and support the forthcoming negotiation process in Phase 2B.

PROPOSED SCOPE OF WORK – REGIONAL SEWAGE SERVICE CONTRACT NEGOTIATION PROJECT, PHASE 2A

Introduction

IEUA and the seven Contract Agencies seek to reach agreement on a revised Regional Sewage Service Contract. To this end, all the Agencies contracted with the Kearns & West Team to meet with the Agencies and determine the issues and potential disagreements with the existing contract. This work, called Phase 1, was completed and a summary presentation was made to a joint meeting of both the Policy and Technical Committees in accordance with the existing Kearns & West contract. At this summary presentation, the Policy Committee discussed options and decided it would be mutually beneficial to continue with the discussions/negotiations currently underway to revise the Service Contract and to use the positive momentum that was established during Phase 1 to reach final resolution on the terms for a revised Contract. The Kearns & West Team was asked to submit a Proposal to hold a "Scoping Session" (called Phase 2A) with the Technical Committee to further refine issues needing to be negotiated, develop a priority list of these issues, and establish a timeline for their resolution. Once this scoping effort is accomplished, the agencies can then decide how best to proceed with the next Phase of actual negotiations (Phase 2B).

The attached table is a budget estimate for a Phase 2A work effort.

Project Goals

In general terms the services under this SOW are intended to provide the Parties with:

- 1) Facilitation and independent technical skills to help further refine and prioritize the issues identified during the Phase 1 effort.
- 2) Assistance in developing a mutual list of common issues to be resolved, a timeline goal for completing Contract renegotiation and determining the best structure going forward to conduct these negotiations.
- 3) Developing a common vision on moving forward.

The same composition of the Kearns & West Team is proposed to continue with the Phase 2A work to maintain continuity and build upon the learning curve established from Phase 1.

Phase 2A Tasks

Phase 2A is an opportunity to take the data collected independently during Phase 1 and for the first time as a group have the parties express individual opinions/views on the identified issues. Collectively the parties would develop a mutual understanding and agreement of issues and concerns to work through and determine a timeline for

resolving them. The structure for these discussions would also be a priority (e.g.- all parties attend all meetings, or a subcommittee from some parties attend all meetings on an issue with a reporting back to the full TAC.)

Task 1- Prepare Issues and Priority Spreadsheet

Based upon the preliminary meetings the Kearns & West Team conducted during Phase 1, we propose to generate a questionnaire outlining the issues which emerged and also provide the agencies the opportunity to add any specific issues they believe were not captured properly. We will transmit this spreadsheet electronically to all Agencies and ask them to prioritize each of the identified issues and to add any additional issues should be included in Phase 2. Our Team will summarize this information and any new data for consideration by the Technical Committee.

Task 2 - Meet with Technical Advisory Committee to Review Issues and Priorities
Once the data is received from the agencies, we will prepare a presentation and facilitate an in-person Scoping Session to build agreement on the questionnaire issues and priorities. The goal of the session will be to confirm issues and priorities, identify area(s) of "easy wins" during negotiations, identify linkages between issues, and prepare a sequence of the issues for the Phase 2 negotiation effort to follow. A discussion on negotiation structure and approach, and a timeline for completion of the Service Contract negotiation, will also be facilitated to assist in guiding Phase 2 efforts.

<u>Task 3 - Prepare Summary of Preliminary Results and Recommendations</u>
The Kearns & West Team will review and compile the results of the Scoping Session and prepare preliminary Phase 2A recommendations for the Technical Committee's consideration and input.

Task 4 - Follow Up Meeting with Technical Advisory Committee

The K&W Team will meet with the Technical Committee a second time to confirm the parties' understanding of, and agreement with, the final questionnaire's list of negotiation issues and priorities, the recommendations for the structure of the negotiations, the identification of "easy wins", the sequencing of issues for negotiations, and the overall negotiation timeline.

Task 5 - Prepare Final Scoping Report

Based on the results of the second meeting, a Final Report will be prepared by the K&W Team describing the Phase 2A process and results. We anticipate this report will be considered by both the Technical and Policy Committees as part of decision making on Phase 2B. Included in the final report will be a draft scope of work and estimated budget for the Phase 2B effort for the parties' consideration.

Phase 2A Schedule

The schedule to complete the Phase 2A effort is primarily dependent on the scheduling of the Task 2 and Task 4 meetings with the Technical Advisory committee. If the Kearns & West team were issued a Notice to Proceed by the end of February 2018, and the Task 2 and Task 4 meetings were held on the same day as the regularly scheduled Technical Committee meetings in March and April, the Task 5 final report could be delivered by the first week in May 2018. This schedule could be shortened by approximately one month (i.e.- completion of Task 5 final report by the first week of April 2018) if the two meetings with the Technical Committee were scheduled sooner and approximately two weeks apart.
