1. TECHNICAL COMMITTEE REPORT

Noel Castillo/City of Montclair reported that the two following action items were approved unanimously at the July Technical Committee meeting:

- The Technical Committee Meeting Minutes of July 26, 2018
- The recommendation of the RP-1 Generator Controls Upgrade design build contract award to Big Sky Electric for \$4.4 million.

2. ACTION ITEMS

A. APPROVAL OF THE MINUTES OF THE JUNE 7, 2018 POLICY COMMITTEE MEETING

<u>Motion</u>: By Peter Rogers/City of Chino Hills and seconded by Eunice Ulloa/City of Chino to approve the minutes of June 7, 2018 Regional Policy Committee meeting.

Motion carried: Unanimously.

B. RP-1 GENERATOR CONTROLS UPGRADE DESIGN-BUILD CONTRACT AWARD

Shaun Stone/IEUA stated that the Generator Controls Upgrade and Switchgear Design Build Contract is for the Regional Plant No. 1. The scope of the project is to replace the 12kV switchgear with spare breaker space, replace control panels for generator control, new digital engine control panels at generators, and provide emergency power during construction. Mr. Stone stated that this project was originally bid on September 2017. A study was completed and the switchgear had failed several key tests. Mr. Stone stated that IEUA had identified the switchgear replacement as a future project as it is 25 years old and parts are obsolete. Big Sky Electric had recommended an added value replacement of the switchgear based on their observations.

Mr. Stone explained that by doing the switchgear now; it would result in a net savings of approximately \$2 million. IEUA selected Big Sky Electric pursuant to SB 785. Mr. Stone then reviewed the project milestones. Mr. Stone requested that the Committee recommend to the IEUA Board of Directors to award the design build contract to Big Sky Electric for \$4.4 million.

Eunice Ulloa/City of Chino asked if there were any issues from CDM or CSI since they did not propose for the replacement of the switchgear. Mr. Stone stated no, the reason being that they did not make the offer originally and cannot go back and amend the added value under SB 785.

Debbie Stone entered the meeting room at 4:12 p.m.

Motion:

By Debbie Stone/City of Chino and seconded by Luis Cetina/Cucamonga Valley Water District to recommend to the IEUA Board of Directors to award the construction contract for the RP-1 12kV Switchgear and Generator Control Upgrades, to Big Sky Electric in the amount of \$4,427,000.

Motion carried: Unanimously.

3. **INFORMATIONAL ITEMS**

A. REGIONAL CONTRACT UPDATE

Mr. Castillo/City of Montclair provided an update on the Sewerage Regional Contract. He stated that negotiations will begin on August 8-9, 2018 where the Technical Committee will discuss the terms that will be utilized throughout the process and reclaim water. Mr. Castillo stated there are about 12 issues to discuss and will take at least 18 months to complete. The Policy Committee will be updated quarterly on the progress. Luis Cetina/CVWD asked what the timeline and what is the approach in addressing each issue. Mr. Castillo stated that at the last Technical Committee meeting, this was discussed. He stated there will be consensus and expect everyone to be subjective and not go backwards with the negotiations.

B. OPERATIONS DIVISION UPDATE

Chander Letulle, Manager of Operations and Maintenance South/IEUA provided an update on the Operations Division. Mr. Letulle reported that IERCA celebrated seven years of no lost time incidents. Mr. Letulle stated that the trends for safety have continued to improve. Mr. Letulle then gave a brief overview on Groundwater Recharge. For Fiscal Years 2017/18, IEUA had a total of 52,000-acre feet (AF). The Agency had the highest amount of imported water recharge of 34,000 AF, the fourth lowest stormwater capture in a 13-year period. Mr. Letulle reported that recycled water deliveries have been steady at 35,000 AF. IEUA has a couple of projects that will provide additional recycled water deliveries, which are the San Sevaine Basin Improvement project as well as the 1158 Recycled Water Pump Station Improvement Project.

Mr. Letulle stated that RP-5 had a coliform violation on August 19, 2017. IEUA believes the cause was due to 19 mud nests in the basins. Operations worked with the Engineering team and had a contractor install devices to deter the birds from nesting in the basins. Mr. Letulle then gave an overview of the operations at the Carbon Canyon Water Reclamation Facility (CCWRF). He discussed the asset management plan and the following maintenance projects performed at the facility: 12KV, aeration, headworks, recycled water pump station inspection, primary clarifier inspection, and headworks condition assessment.

C. LEGISLATIVE UPDATE

The Legislative Update was received and filed by the Committee.

D. KEARNS & WEST REGIONAL CONTRACT FACILITATION CONTRACT AMENDMENT

The Kearns & West Regional Contract Facilitation Amendment was received and filed by the Committee.

5. OTHER BUSINESS

A. IEUA GENERAL MANAGER'S UPDATE

- Halla Razak informed the Committee that the California Water Commission (CWC) awarded the Chino Basin Conjunctive Use Project \$206 million. IEUA has started doing analysis funding, environmental impact, and security agreements. IEUA will update the Committee on the progress. Ms. Razak thanked everyone for their letters of support.
- Ms. Razak asked Mr. Stone to discuss the plan check fee. Mr. Stone stated that IEUA is reinstating the plan check fee to cover the level-of-effort to perform plan review and inspection. Ms. Ulloa asked if IEUA will be notifying the contracting agencies. Mr. Stone stated this item will be going to the board in August for their approval as a resolution. IEUA informed the Technical Committee at the July meeting and a letter will be sent if the Board approves.

B. COMMITTEE MEMBER REQUESTED AGENDA ITEMS FOR NEXT MEETING

Mr. Cetina requested an outline and timeline on each segment and parameters on the Regional Contract negotiations be provided at the next Committee meeting.

C. COMMITTEE MEMBER COMMENTS

Ms. Martinez thanked the Committee for their support and prayers for Mayor Eaton, who passed away on July 22.

RECOMMENDATION

It is requested that the Regional Committees recommend the IEUA Board of Directors award the construction contract for the RP-5 RW Pipeline Bottleneck, Project No. EN14043, to T.E. Roberts, Inc., in the amount of \$2,023,600.

BACKGROUND

Regional Water Recycling Plant No. 5 (RP-5) has been operating and producing quality recycled water (RW) pursuant to the State of California Title 22 regulations since 2004. The RP-5 RW Pipeline Bottleneck project was launched after completing the 2015 RW Program Strategy with a primary goal to maximize the recharge and beneficial reuse of the RW. To achieve this goal, it is essential to upgrade the RW piping system, remove existing hydraulic limitations, and enhance system reliability.

The project improvements include up-sizing and reconfiguring the existing piping system downstream of the RW pump station, installation of a surge control system, replacement of buried RW isolation valves throughout the RP-5 Plant, and upgrade of pressure regulating devices and flow meters.

This project will be funded under California Clean Water State Revolving Fund Program with principle forgiveness of 50% of the total project cost.

In September 2016, the Inland Empire Utilities Agency (IEUA) retained Stantec Consulting Services, Inc. (Stantec) to provide consulting engineering services associated with the project including design, construction administration services, and commissioning. Stantec completed the design phase in November 2017.

Upon completion of the design in November 2017, IEUA prequalified nine general contractors to bid on the project. On May 9, 2018, IEUA released an invitation for bid to the eligible contractors through *PlanetBids*. Six out of the nine prequalified contractors participated in the job walk on May 17, 2018.

T.E. Roberts, Inc., was the lowest responsible responsive bidder with a bid price of \$2,023,600. T.E. Roberts was pre-qualified by IEUA by presenting the required experience on performing similar projects with other utilities and cities showing good workmanship and responsiveness. T.E. Roberts' bid forms met the required submittal and demonstrated a good faith effort to solicit for disadvantage and small business enterprise as required by California Clean Water State Revolving Fund Program.


IEUA RECYCLED WATER DISTRIBUTION – JULY 2018



Septic to Sewer Feasibility Study Update











Preliminary Negotiation Schedule, Topic Sequence, Progress Tracking

As requested by the TC, we have developed a preliminary negotiation schedule for review and discussion with the TC. We also have developed a preliminary sequence of topics for negotiation based on results of the Phase 2A survey, and a template for tracking progress on negotiation of those topics. Additional information about each item follows.

Our goal is to strike a balance between establishing reasonable shared expectations about how the contract negotiations will take place, and ensuring that all Contract Agencies understand the need for flexibility to make adjustments based on experience. Our proposed approach incorporates structure, guidelines, and consistency, along with transparency in decision making about future course changes.

Preliminary Negotiation Schedule. We developed a very preliminary schedule (July 2018-February 2019) for negotiations in response to a TC request. This preliminary schedule is organized around guidance provided by the TC regarding likely availability, including information about potentially competing commitments such as City Council meetings or Watermaster sessions. We assumed it would be useful to report back to the PC on a quarterly schedule about progress. We also assumed it would not be desirable for a majority of the TC to be negotiating during consecutive weeks and made schedule shifts to create spacing. As with the Preliminary Issue Sequence (below) we view this preliminary schedule as a starting point that is subject to modification as needed by the TC. *One important step will be to confirm availability of TC members and the K&W team for each planned session*. Once you have approved a model negotiation schedule we will confirm dates through the end of 2019.

Preliminary Negotiation Issue Sequence. We developed a preliminary proposal for sequencing negotiation topics in response to a TC request. We made initial sorting decisions into Groups A and B of the comprehensive list of topics developed in Phase 2A. We assumed that each topic in Group A would be addressed using the negotiation steps described in our report back to the TC; we made a similar assumption for Group B topics, with fewer steps also as described. Negotiation steps will be reviewed and confirmed or adjusted when the TC initiates discussions on specific topics. We identified topics to start with for Groups A and B during the first three months of negotiations (July – September). In each following quarter we would confirm negotiation topics in consultation with the TC. This quarter-by-quarter approach allows for adjustments and flexibility.

This preliminary sequence is best viewed as a starting point rather than a fixed approach; the actual negotiation process likely will involve sequence adjustments, various topic combinations, and learning that could improve efficiency.

Preliminary Negotiation Progress Templates. We believe it will be useful to track negotiation progress using a consistent template and have created two preliminary versions, for Group A and Group B topics. Each topic will have its own tracking sheet that is updated as we progress through specific negotiation steps. No time is fixed for any single step, and steps can be combined.

Evaluating Progress. We appreciate the importance of being able to document progress in contract negotiations. Progress can be subjective and unpredictable; sometimes a period without apparent progress is needed to generate progress. We recommend a quarterly review of progress in the TC that relies on results reflected in tracking tools described above as well as each Contract Agency's perspectives. We also recommend a quarterly progress update to the PC by the TC.
