## **Inland Empire Utilities Agency Seats Board Members**

**Inland Empire, California** – Michael Camacho and Marco Tule were recently sworn in as directors to the Inland Empire Utilities Agency’s (IEUA/Agency) Board of Directors (Camacho is a returning director).

Director Camacho has served on the IEUA Board since 2009 and will begin his fourth, four-year term in office, representing Division 5, which includes the city of Rancho Cucamonga, unincorporated territories in the city of Rancho Cucamonga’s sphere of influence, a portion of city of Fontana, and a portion of the unincorporated territories in Fontana’s sphere of influence. Director Camacho is also the Agency’s representative on the Metropolitan Water District of Southern California’s Board, and serves as the Vice Chair for the Inland Empire Regional Composting Authority, Chair of the Agency’s Engineering, Operations and Water Resources Committee, first alternate for the Community and Legislative Affairs Committee and Finance and Administration Committee, an alternate for the Santa Ana Watershed Project Authority Commission, the Association of California Water Agencies, and the Chino Basin Watermaster.

“It is an honor to be re-elected to serve my fourth term as a Board Member for IEUA,” stated Board Member Michael Camacho. “IEUA continues to excel as a leader in water resource management and environmental stewardship, and I am committed to utilizing my experience and the knowledge I’ve gained to continue representing our constituents and ensuring a high-quality and reliable water supply in a cost-effective manner.”

Director Tule will begin his four-year term in office, representing Division 1, which includes the cities of Upland and Montclair, the unincorporated area of San Antonio Heights, and a portion of the cities of Ontario and Rancho Cucamonga. Director Tule is a Senior Environmental Engineer and Sustainability Program Manager who works to ensure organizational compliance with all State and Federal environmental laws. He directs environmental sustainability and recycling programs, which includes overseeing environmental permits related to wastewater, contaminated soil and stormwater.

“I am honored to be elected to the IEUA Board of Directors. IEUA is recognized as a pioneer in the industry, and I look forward to offering my leadership and experience in environmental sustainability to serve the community,” stated Board Member Marco Tule. “I am committed to working with my fellow Board Members, Agency staff and members of the community to ensure the Agency continues to provide essential services to meet the needs of the region.”
