Subject: Adopt Resolution No. 2021-11-6, Making Certain Findings and Determinations Regarding Special Rules for Conducting Meetings through Teleconference

Executive Summary:

On March 4, 2020, Governor Newsom declared a state of emergency pursuant to Government Code 8625 due to the COVID-19 pandemic and recommended, together with local officials, measures for social distancing to assist in abating the spread of COVID-19; and on March 17, 2020, the Governor issued Executive Order N-29-20 which, among other things, suspended certain Brown Act rules governing the use of teleconferencing for local agency board meetings. Executive Order N-29-20 expired on September 30, 2021. In response to the ongoing COVID-19 pandemic, the California legislature has enacted, and the Governor has signed into law, AB 361 amending portions of Government Code 54953, allowing for the continued use of teleconferencing for local agency board meetings while suspending the conditions and restrictions of Government Code 54953(b)(3) if the legislative body of the local agency makes certain findings. The legislative body must make these findings every 30 days to continue the use of teleconferencing.

Staff is recommending that the Board of Directors makes the necessary findings and determinations and Adopt Resolution No. 2021-11-6 to continue to conduct meetings through teleconference for a period of 30 days.

RESOLUTION NO. 2021-11-6

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE INLAND EMPIRE UTILITIES AGENCY*, SAN BERNARDINO COUNTY, CALIFORNIA, MAKING CERTAIN FINDINGS AND DETERMINATIONS REGARDING SPECIAL RULES FOR CONDUCTING MEETINGS THROUGH TELECONFERENCE

WHEREAS, Inland Empire Utilities Agency ("IEUA") is a municipal water district established pursuant to Section 71000 et seq. of the California Water Code; and

WHEREAS, all meetings of the Board of Directors of IEUA are conducted in open and public settings in compliance with the Ralph M. Brown Act (Brown Act) so that any member of the public may attend, participate and watch the Agency's Board of Directors conduct their business; and

WHEREAS, on March 4, 2020, the Governor declared a state of emergency pursuant to Government Code 8625 due to the COVID-19 pandemic and has recommended, together with local officials, measures for social distancing to assist in abating the spread of COVID-19; and

WHEREAS, on March 17, 2020, the Governor issued Executive Order N-29-20 which, among other things, suspended certain Brown Act rules governing the use of teleconferencing of local agency board meetings; and

WHEREAS, the California legislature has enacted, and the Governor has signed into law, AB 361 amending portions of Government Code 54953, allowing for the continued use of teleconferencing for local agency board meetings while suspending the conditions and restrictions of Government Code 54953(b)(3) if the legislative body of the local agency makes certain findings; and

WHEREAS, On October 6, 2021 the Board of Directors of the Inland Empire Utilities Agency approved Resolution 2021-10-1 making certain factual findings, and authorizing the continued use of teleconferencing for IEUA Board meetings for an effective period of 30 days; and

WHEREAS, the Board of Directors must now determine whether to extend the effective period of Resolution 2021-10-1 for an additional 30 days, making the appropriate factual findings in support thereof;

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Inland Empire Utilities Agency hereby make the following findings and determinations:

SECTION 1. The Governor has proclaimed a state of emergency on March 4, 2020 which continues.

SECTION 2. The Governor and local officials have promoted the use of social distancing as a method to abate the spread of COVID-19 within the community. The Board of Directors finds that conducting in person meetings of the IEUA Board of Directors would be inimical to social distancing and would present imminent risks to the health or safety of the attendees and conducting meetings by teleconference would diminish that risk.

SECTION 3. The Board of Directors will continue to conduct Board meetings by teleconference in compliance with Government Code 54953(e) until such time as the Governor has terminated the state of emergency and the risk to health and safety of meeting attendees is sufficiently diminished or as otherwise required by law. Notice of meetings and posted agendas will contain information which allows members of the public to access the meeting and address the Board of Directors and offer public comment including an opportunity for all persons to attend via a call-in option or an internet-based service option.

<u>SECTION 4.</u> This Resolution shall take effect immediately upon its adoption and shall be effective for 30 days or until such time as the Board of Directors adopts a subsequent resolution in accordance with Government Code 54953(e)(3) to extend the time during which meetings of the Board of Directors may be conducted by teleconference without compliance with Government Code 54953(3)(b).




Agency Redistricting

Background

- California Water Code requires municipal water districts to adjust division boundaries after each decennial U.S. census.
- Based on census information, boundaries may need to be adjusted so that divisions represent populations that are nearly as equal as possible.
- Criteria to be considered:
 - To the extent practicable, geographic integrity of local neighborhoods or areas of community interest should be considered when re-drawing division boundaries.
- Divisions must be in compliance with federal Voting Rights Act
- In 2010, IEUA's service area population was approximately 814,000
 - Each director represented an average of 163,000 residents

Fair Maps Act



- Does not apply to special districts, but we will use it as a guide to ensure a transparent and participatory process.
- Intent is to create standardized redistricting criteria to better keep communities together and prevent partisan gerrymandering.
- Requires agencies to hold public hearings and allow more opportunities for public participation in map drawing process.
- Special districts must hold at least one public hearing.
 - Recommend three public hearings:
 - 1) Seek input from community members and stakeholders before lines are drawn
 - 2) Receive public input on proposed maps
 - 3) Final hearing for adoption of a map (must be made public for seven days prior to adoption)
- Hearing dates/times will vary to help engage members of the public who may not be able to attend during traditional business hours.

Public Outreach

- To ensure a diversity of community voices participating in the process, we will enhance traditional outreach
 - -Hold two of three hearings in the community rather than at IEUA headquarters
 - Provide remote access to hearings
 - Dedicated web page on ieua.org
 - · Include video of hearings for residents who were unable to attend
 - Include an online method for submitting written feedback
 - Provide outreach materials in English, Spanish and Chinese (Cantonese and Mandarin)
 - Distribute through print media, social media, LinkedIn, Nextdoor app, and local elected officials

Prison Populations



- U.S. Census counts prisoners as residents of the prison location.
 - Referred to as "prison gerrymandering"
- Eleven states including CA have passed legislation to end this practice:
 - Prisoners will be re-allocated to their respective districts using last known address
 - Those from out-of-state or without a last known address won't be counted



- Prison is defined as state or federal facilities that house convicted felons with a sentences typically longer than one year.
- In California, it is required for congressional and state legislative boundaries, as well as counties and cities.
- Optional for special districts

GIS Mapping




- Working with Redistricting Partners, three successive maps will be created in-house based on input received at public hearings.
- Additional datasets can be used to help define communities of interest, critical geographic elements, and where people live.




2010 Census Population Totals






