Scope: It is the Agency's intent to rehabilitate the Regional Water Reclamation Plant No. 5 (RP-5) tertiary filters by replacing the air lift pumps. Tertiary filtration at IEUA's Regional Water Reclamation Plant No. 5 (Attachment A) consists of 12 filter cells with each cell comprised of 6 individual Dynasand filters for a total of 72 Dynasand Filter modules. Dynasand Filters as manufactured by the Parkson Corporation are continuous backwash, up flow filters that provide physical treatment to remove suspended solids and reduce the turbidity of the secondary effluent.
