**INLAND EMPIRE, CA** – The Drug Enforcement Administration's (DEA) National Prescription Drug Take Back Day will be held Saturday, April 22, from 10:00 AM to 2:00 PM. On this date, facilities throughout the region will open their doors to receive unwanted, unused, and expired prescription medications. **No questions asked.**
