#### **CALL TO ORDER**

A meeting of the Inland Empire Utilities Agency (IEUA)/Regional Sewerage Program Policy Committee was held on Thursday, October 5, 2023, at 6075 Kimball Avenue, Building A, Chino, California.

Chair Randall Reed/Cucamonga Valley Water District (CVWD) called the meeting to order at 3:30 p.m. Recording Secretary Jennifer Hy-Luk established a quorum was present. Chair Reed led the Pledge of Allegiance.

#### **ADDITIONS TO THE AGENDA**

#### 1. TECHNICAL COMMITTEE REPORT

Amanda Coker/CVWD stated that the Technical Committee approved the July 27, 2023 Technical Committee meeting minutes; heard the Pretreatment & Compliance Updates, Grants Semi-Annual Update, Regional Wastewater Fee Collection, and Recycled Water Study. Ms. Coker stated that the Technical Committee recommended that the Regional Wastewater Fee Collection be brought to the BAR Subcommittee for discussion.

#### 2. ACTION ITEM

#### A. APPROVAL OF THE SEPTEMBER 7, 2023 POLICY COMMITTEE MEETING MINUTES

<u>Motion</u>: By Committee member Ulloa/City of Chino and seconded by Committee member Rogers/City of Chino Hills to approve the meeting minutes of the September 7, 2023 Regional Policy Committee Meetings by the following vote:

The motion passed by a vote of 7 ayes, 0 noes, 0 absent, and 0 abstain.

#### 3. INFORMATION ITEMS

#### A. GRANTS SEMI-ANNUAL UPDATE

Alyson Piguee/IEUA provided the update.

#### B. REGIONAL WASTEWATER FEE COLLECTION

Kristine Day/IEUA provided the presentation.

Committee member Velto/City of Upland expressed the importance of verifying addresses and questioned the impact on customers. Committee member Dutrey/City of Montclair stated that direct invoicing is easier so that customers can pay all fees at one location.

IEUA General Manager Deshmukh reiterated that the item was brought to the Board of Directors and the Policy Committee solely as an information item. He stated that the Board has no recommendation on the item.

Mr. Dutrey stated that he is leaning towards having IEUA take over the Equivalent Dwelling Unit (EDU) rate, but he would like to further discuss with City staff. Mr. Dutrey stated that the Policy Committee should continue to explore this option.

Mr. Velto stated that he thinks it is important for the EDU rates to be handled by the city while the Capital Capacity Reimbursement Account (CCRA) fees with the builder or developer be handled by IEUA since residents are already coming to the city to get their water turned on.

Committee member Rogers/City of Chino Hills stated that both he and alternate Committee member Art Bennet have noted their concerns to GM Deshmukh and Board Vice President Steven Elie.

Committee member Marco Tule/IEUA confirmed that the Agency has heard the Policy Committee members' concerns and stated that there will need to be more discussion on the topic.

Committee member Ulloa/City of Chino asked whether the information was modeled after a water district that handles all their collection of fees, like Eastern Municipal Water District. IEUA Assistant General Manager Day stated that staff gathered data from multiple sources, such as Orange County Sanitation District, Los Angeles County, and cities. Ms. Day stated that all options were presented as each option would represent different considerations, challenges, and impacts.

Chair Reed stated that there are advantages to CVWD handling the fees, such as direct customer contact and the revenue generated by fees. He stated that with builders and homeowners at times it is hard to explain the CCRA fees, but he hasn't not heard concerns from their staff.

AGM Day stated that IEUA can attend any Prop 218 hearings or City Council or Board meetings to assist with any questions. Committee member Dorst-Porada/City of Ontario requested that IEUA assist throughout the year to provide outreach and notify residents of IEUA's role in the water billing and rates.

Committee member Tule stated that he would like to see one regional hearing for Prop 218 instead of replicating efforts seven or eight times for each agency.

#### C. REVIEW OF RECYCLED WATER

Eddie Lin/IEUA provided the report.

Mr. Dutrey requested a timeline and clarification on the agencies involved. Mr. Lin stated that it is generally a one-year timeline and stated that it would include all of IEUA's retail recycled water customers.

GM Deshmukh added that there are many stakeholders, and the item was discussed at the quarterly GM meeting on October 4.

#### A. IEUA GENERAL MANAGER'S UPDATE

General Manager Shivaji Deshmukh stated that in response to Committee member Dorst-Porada's comment, IEUA recognizes the importance of coordinated outreach. He shared that one of his top three goals is to continue to develop how the Policy Committee members work together and what IEUA can do to support customers.

Committee member Dorst-Porada stated her appreciation for Chair Reed and Monte Vista Water District Director Sandra Rose for speaking at the October 4 State Water Resources Control Board (SWRCB) Meeting. She mentioned their Water Conservation Draft Plan is an important item that all Policy Committee members should be aware of, as the intended requirement is to have a significant amount of water savings in each city.

Discussion ensued about the SWRCB Making Conservation a Way of California Life regulation.

Mr. Tule stated his appreciation for Councilmember Dorst-Porada, Chair Reed, and Director Rose for attending the SWRCB meeting and making them aware of the region's challenges.

Chair Reed brought attention to the region's reservoir issue.

#### RECOMMENDATION

This is an information item.

#### **BACKGROUND**

The IEUA Board of Directors adopted charges for the following rates and fees through fiscal year (FY) 2024/25:

- Wastewater Connection Fee
- Monthly Equivalent Dwelling Unit Rate
- One Water Connection Fee
- Monthly Meter Equivalent Unit Rate
- Recycled Water Direct Use Rate
- Recycled Water Groundwater Recharge Rate
- Recycled Water Fixed Cost Recovery Fee

With these charges set to expire soon, an updated study is required to develop fees and rates that appropriately recover the cost of service for each of the programs, as well as support the Agency's long-term Capital Improvement Plan. IEUA posted a request for proposals (RFP) on PlanetBids on October 12, 2023, and through a qualification-based selection, the evaluation team unanimously agreed Black & Veatch was the best qualified to complete the study based on an evaluation analysis, interview, and project team expertise.

The IEUA Board of Directors awarded the contract for the 2024 Rate and Fee Study to Black & Veatch during a regular board meeting on December 20, 2023. Project kickoff with the consultant occurred on January 11, 2024 and the Board of Directors is anticipated to adopt the new fees and rates by end of December 2024. Throughout the study process, IEUA intends to solicit input and feedback from customer agencies.




## **Project Background**

The previous rate study effort initiated in 2019 and established several rate structures through the end of Fiscal Year (FY) 2024/25. Project highlights include:

- Updated connection fees and/or rates for water, wastewater, and recycled water (MEU and water connection fee completed 2020, recycled completed 2022)
- Fixed cost recovery fee added to recycled water charges
- Stakeholder outreach conducted and peer review by the Building Industry Association (BIA)

The following rates will be evaluated for **FY** 2025/26 through 2029/30:





## **Wastewater Fee and Monthly Rate Overview**

<u>Wastewater Connection Fee:</u> Fee applied to all new wastewater connections.

 Supports the timely capacity expansion and improvement of the Agency's regional wastewater system to meet future growth and facilitate economic development.

Monthly Wastewater Rate: Reoccurring monthly charge for use of the regional wastewater system. Residential is based on one EDU while Commercial and Industrial are adjusted for flow and loading.

• Supports wastewater operations and maintenance, capital replacement and rehabilitation projects, and debt service costs.

## One Water Fee and Monthly Rate Overview

One Water Connection Fee: Fee assessed on new and upsized connections to the Agency's regional water system (imported and recycled).

 Supports the expansion of the regional water system and investment in integrated regional water resources.

Monthly Water (MEU) Rate: Reoccurring monthly charge for use of the regional water system.

 Supports management and distribution of imported water supplies, development and implementation of regional water use efficiency initiatives, water resource planning and support for regional water supply programs. The One Water Connection Fee and Monthly Rate are calculated based on a meter equivalent unit (MEU), or a residential unit based on 5/8" and 3/4" meter sizes.

### **Recycled Water Rates Overview**

Recycled Water Direct Use Rate: Volumetric charge for direct recycled water use billed per acre-foot (AF) delivered to users.

• Supports recycled water deliveries including operations and maintenance, administration, and capital replacement and rehabilitation.

Groundwater Recharge Rate: Surcharge added to the direct use charge per AF levied on recycled water delivered to recharge groundwater basins for future use.

 Supports a portion of groundwater recharge basin maintenance and operation costs not reimbursed by the Chino Basin Watermaster.

Recycled Water Fixed Cost Recovery Fee: Fixed fee charged per year that is based on a three-year rolling average of direct and recharge recycled water use.

Supports debt service cost recovery for the recycled water program. This fee was phased in from FY 2022/23 to FY 2024/25.


## Request for Proposals (RFP) Process


